Homes overview and summary

Homes list and occupancy overview

Occupancy across the six in-house older people's homes has not been fully maximised and four of the six homes have units that are permanently closed. In the table below, 'registered beds' represents the number of beds registered within the home, whereas 'available beds' represents the number of beds that are open and available for use.

In the homes with higher occupancy utilisation, the occupancy levels present significant challenges in respect of care provision due to the size and suitability of accommodation.

Please note that the most recent data from Colliers International reviewing care home performance in the second half of 2013, states that average occupancy of residential care homes (personal care) was 89.6%.
