#### 8 UPDATE ON HOUSEBOATS

Agenda Item Only

The vast majority of the residents are now paying rent and have agreed payment plans for any arrears.

4 additional boats had been moored at Scotland Bridge as the residents had changed boats and had not disposed of their old boats. One has now been sold & taken away; one has been bought by a neighbouring resident who is a carpenter & he is working on it before getting rid of his old one; the other 2 have been sold and are currently being made riverworthy before being taken down the Thames.

Anyone with an outsized boat or outbuilding has been advised that they will have to remove it when they leave the mooring plot.

A draft 'Heads of Terms' document has been sent to the residents summarising the main points of a potential new lease starting in 2012, when the current one runs out. New leases will only be granted if residents are up to date with their rent and not in breach of any of the covenants of their current lease.

There is still a problem with crime in the public car park at night, mainly vandalism of vehicles at night. Quotes have been obtained for installing CCTV, but the cost cannot be justified until the current level of arrears has been reduced.
