#### CONSULTATION ON THE SOUTH LONDON WASTE PLAN

- (1) That the proposed strategic approach of net-sufficiency and the general distribution of proposed sites for waste development be supported.
- (2) That concern be expressed about the potential waste traffic generated through Epsom town centre should the coal depot adjacent to Barwell Business Park (Site 46) be allocated for waste development;
- (3) That the South London Waste Plan's views on mass-burn incineration be endorsed.
- (4) That the questionnaire response set out in Annex 1 to the report submitted be agreed, subject to the addition of the following:

**Question 4b** re. sites identified in Table 2.5: After comment regarding site 45, to add the following text in the Comment Box, 'On site 36, further constraints may include proximity to Epsom Common SSSI and Local Nature Reserve in Surrey, and more importantly the Ashted Common SSSI and National Nature Reserve in Surrey which contains over 2,300 rare pollarded oaks which are of great conservation importance.'

**Question 11** re. Policy WP4: Insert the following comment in the Comment Box, "In the interests of maximising landfill diversion, the policy should also refer to ensuring that existing recovery rates are not compromised when an existing waste site is re-developed for waste management use'.
