SUBJECT: RESPONSE TO THE CONSULTATION OF A PLAN FOR WASTE

MANAGEMENT (THE REVISED JMWMS)

KEY ISSUE/DECISION:

The Joint Municipal Waste Management Strategy (JMWMS) is a statutory document, which was produced in 2006 and was adopted by all authorities in Surrey at the end of 2006 or early in 2007. Setting out a 20-year plan for the management of household waste in Surrey, it is currently about half-way through its first period leading up to a full review. An interim review was agreed by the Surrey Waste Partnership.

Changes have been made to the original Strategy because of new legislation (both English law and EU Directives), new national targets (such as the National Waste Strategy 2007), and new local targets (such as the agreed Surrey target of 70% recycling by 2013/14), and because of areas in the original JMWMS which have been achieved or are now out of date.

This report represents the proposed Waste Disposal Authority's (WDA) response to the consultation.

The Secretary of State for Environment has recently announced a review of National Waste Policy aimed at key strategic objectives. In the view of the WDA, the JMWMS is therefore consistent with the strategic objectives.

DETAILS:

Consultation

 The Environment and Economy Select Committee has been consulted on the changes to the strategy and as a result supports the 2010 revision, A Plan for Waste Management.

4. An equality impact assessment is being carried out for the revised strategy and will be completed following the conclusion of the consultation. This will form part of the final report as part of the adoption of the revised strategy.

6. If adopted, the revised strategy will have a positive effect on targets and LAA. The policies within the strategy represent an upgrade to the current targets.

The policies and the actions within the strategy have a positive effect on the carbon emissions, for example the reduction in vehicle movements and the production of energy from Surrey's food waste and residual waste.

REASONS FOR RECOMMENDATIONS:

The Waste Disposal Authority (WDA) strongly supports and endorses the proposed amendments to the Surrey Joint Municipal Waste Management Strategy, which it sees as an essential document in the delivery of a modern infrastructure for dealing with municipal waste.

The WDA has a statutory responsibility for making arrangements for the disposal of municipal waste collected by district and borough councils and for providing civic

amenity sites where members of the public can bring household waste materials for recycling and disposal.

Since the adoption of the current JMWMS in 2006, the councils in Surrey have made significant progress in adopting the aims of that strategy.

Ultimately the success of both the JMWMS and the WDA Action Plan in achieving their objectives will depend on the ability to develop new recycling, anaerobic digestion, composting and treatment facilities within the county.
