#### 10. ORIGINAL MOTIONS

(i) Mr Nick Skellett CBE (Oxted) to move under Standing Order 10 as follows:

'This Council agrees to:

- Note and endorse Ofsted's assessment that the universal service to children and young people in Surrey is good and that the County offers value for money.
- 2. Note and welcome the improvements to services for vulnerable children, which have been reported to the Improvement Board.

In light of which the Council further agrees to:

- 3. Thank managers and staff for their commitment and work in ensuring progress across all services in the directorate.
- 4. Confirm its confidence in the capacity of the staff and the adequacy of the services to continue building on these achievements.'

# (ii) Hazel Watson (Dorking Hills) to move under Standing Order 10 as follows:

'This Council notes that the Conservative administration's failed policies over the last four years have resulted in the Council being demoted from a three star to a one star authority.

The Council further notes that millions of pounds of council taxpayers' money have been wasted through:

- (1) the failure of the aims of the Business Delivery Review (BDR) resulting in decisions and redundancies being reversed;
- (2) the failed move of County Hall from Kingston to Woking:
- (3) failure to manage the workforce properly resulting in over-reliance on agency staff and consultants;

- (4) failure to provide waste facilities on time, and the consequences thereof;
- (5) failure to update IT systems to ensure that they are fit for purpose;
- (6) failure to reduce costly out-of-county placements for children with special needs;
- (7) failure to properly manage the highways contract;
- (8) the failure to establish the transport co-ordination centre on time;
- (9) failure to open new respite care facilities on time;
- (10) failure to manage the budget properly;
- (11) failure to improve energy efficiency in Council buildings and address the issues of Climate Change with the prompt appointment of a Climate Change officer and the adoption of a Climate Change strategy.

The Council calls upon the Leader of the Council to apologise to the people of Surrey.'

# (iii) Dr Andrew Povey (Waverley Eastern Villages) to move under Standing Order 10 as follows:

'This Council welcomes the publication of the Conservative Party Green Paper on localism. In particular the Council supports:

- the proposed abolition of all regional planning and housing powers exercised by regional government and the returning powers and discretion back to local councils;
- 2) the proposed abolition of the Comprehensive Area Assessment (CAA) and the further curtailing of the number of central targets;
- 3) the proposal to allow councils to establish their own local enterprise partnerships to take over the economic development functions of Regional Development Agencies (RDAs).
