## 53/09 DECLARATION OF PERSONAL AND PREJUDICIAL INTERESTS (ITEM 6)

### 54/09 VICE-CHAIRMAN (ITEM 7)

Upon the motion of Mrs Margaret Hicks, seconded by Mr Nick Harrison, it was unanimously:

Mrs Sealy was invested by Mr Marlow with the Vice-Chairman's badge. She made the statutory declaration of office and expressed thanks to the Members of the Council for electing her as Vice-Chairman.

### 56/09 MOTION OF THANKS TO RETIRING CHAIRMAN (ITEM 8)

Upon the motion of the newly elected Chairman, seconded by Mrs Hazel Watson, followed by speeches from the Leaders of the Conservative and Residents' Association / Independent and the Labour representative in support of the motion, it was:

### **RESOLVED**:

That the Chairman and Members of the Surrey County Council, record our warm appreciation of the distinguished services given to the County and its inhabitants by Mrs Angela Fraser DL during her tenure of office as Chairman of the Council from 15 May 2007 to 23 June 2009.

The Chairman presented Mrs Fraser with an inscribed copy of the motion together with an ex-Chairman's badge. Mrs Fraser made a farewell speech.

## 57/09 ELECTION OF LEADER OF THE COUNCIL (ITEM 9)

Upon the motion of Mr David Hodge, seconded by Mrs Denise Saliagopoulos, it was:

### **RESOLVED:**

That Dr Andrew Povey be elected Leader of the Council for the a four year term, expiring on the day of the post election annual meeting in 2013.

Dr Povey expressed his thanks to Members of the Council for electing him as Leader.

### 58/09 **REPORT OF THE LEADER (ITEM 10)**

The newly elected Leader made a detailed statement setting out his vision for the future of Surrey for the next four years. He announced the renaming of the Executive to Cabinet and the appointment of a Deputy Leader and the Cabinet Members. Copies of their portfolios for the council year 2009/10 were tabled at the meeting. (Appendix A)

He also set out his objectives for the next four years. These included his intention to delegate some decisions to individual Cabinet Members to enable the full Cabinet to concentrate on more strategic issues at their monthly meeting.

He said there would be more powers for Local Committees, namely, approval of the youth plan, signing off the Highways community gangs work by Local Members and amending the process for HGV operator licences to include consultation with Local Members.

He said he would retain the following powers as Leader:

- Any matter affecting the boundaries of or development within the Green Belt / AONB / AGLV.
- The final decision to open / close a school.
- The establishment of and recruitment to posts evaluated with a pay band in excess of £100K and consultants on contracts over £100K.
- Expenditure against the agreed Policy Initiatives Budget and Future Income fund.

He also made three major announcements:

- To reduce speeding and anti-social driving on Surrey roads, he said that £1m would be allocated for a joint initiative with Surrey Police.
- He pledged to increase re-cycling across the Council, working with Districts and Boroughs to build on successes already achieved and also said that this would be an opportunity to remove or reduce reliance on Energy from Waste plants in Surrey, with officers asked to look at other options as a matter of urgency.
- Specific incentive packages to recruit and attract high calibre social workers to Surrey, offering 50 bursaries to students of £1,500 p.a. (with priority given to Surrey residents.

Finally, he informed Members of his first '100 day targets', namely launching a speeding initiative and one other safety initiative; starting the first Public Value Review, which will be on Adult Social Care (with all services being reviewed over a three year period) and increasing support for the business community.

- (3) That the County Councillors for each district / borough area be appointed to serve on the appropriate Local Committee for the council year 2009/10, and that the Chief Executive be authorised to appoint an equal number of district / borough councillors to the Local Committees following nominations by the district and borough councils.
