10. STATEMENTS BY MEMBERS

Any Member may make a statement at the meeting on a local issue of current or future concern.

11. ORIGINAL MOTIONS

(i) Mrs Hazel Watson (Dorking Hills) to move under Standing Order 11 as follows:

'This Council recommends that the Cabinet provides the necessary funding to implement the reduced speed limit schemes already approved by the Local Committees in order to:

- (i) avoid the waste of money already spent on approving and developing such schemes as speed surveys are time limited;
- (ii) avoid overruling and undermining democratic decisions made by Local Committees; and
- (iii) improve road safety and reduce the number of road traffic accidents resulting in death and personal injury which bring human suffering and financial costs.'

(ii) Mr Eber Kington (Epsom and Ewell North) to move under Standing Order 11 as follows:

'This Council expresses its concern at the process adopted for scrutinising and determining a revised Policy for Civil Parking Enforcement in Surrey. In particular, it notes that report to the Transportation Select Committee meeting held on 25 May 2010:

- contained limited analysis of the options in terms of pros and cons
- contained no risk analysis of each option
- contained limited justification as to why the option recommended was the most appropriate.

In addition the Council expresses its concern that the timetable proposed for discussions by the Cabinet Member for Transport did not allow for a proper consideration of the report at a public and open meeting of each Local Committee.

This Council therefore calls upon the Leader and Members of the Cabinet to ensure that future policy changes are subject to proper scrutiny by the relevant Scrutiny Committee and where appropriate Local Committees, through the provision of timely reports which contain all appropriate information, including financial costings and a risk analysis.'

(iii) Mr David Hodge (Warlingham) to move under Standing Order 11 as follows:

'That this Council:

- a) Welcomes the decision of the new Secretary of State for Communities and Local Government, Rt. Hon Eric Pickles, to scrap many league tables for local government and also the abolition of the Comprehensive Area Assessment (CAA);
- b) Is concerned that, under the previous government, inspections were seen almost as an end in themselves, rather than a means to improving outcomes for residents;
- c) Believes that being able to deliver value for money services and make Surrey County Council a World Class local authority depends on having robust performance management and Quality Assurance systems driven by and within the council; and
- d) Believes that the existence of the aforementioned systems and processes will help us deliver good quality services for the residents and businesses of Surrey.'

(iv) Mr Tim Hall (Leatherhead and Fetcham East) to move under Standing Order 11 as follows:

'That this Council:

- a) Recognises that the country is in a parlous financial state as a result of the previous government's mishandling of the economy and profligate overspending;
- b) Is cognisant of the fact that the coalition Government has inherited from its predecessor the largest budget deficit of any economy in Europe with the single exception of Ireland;
- c) Acknowledges that the coalition government faced difficult challenges in preparing its emergency budget;

- d) Supports the coalition government's efforts to reduce the deficit whilst attempting to protect frontline services where possible;
- e) Welcomes the honesty about the country's finances as articulated by the Chancellor and Chief Secretary to the Treasury;
- f) Resolves to work with the government to take advantage of their pledge to help local authorities to freeze Council Tax; and
- g) Will continue to press the government for a fairer share of funding for Surrey.'

(v) Mrs Mary Angell (Woodham and New Haw) to move under Standing Order 11 as follows:

'That this Council:

- Notes the content and aims of the Private Member's Bill put forward by the MP for Mole Valley, Sir Paul Beresford, to amend the Domestic Violence, Crime and Victims Act 2004;
- b) Agrees to support Sir Paul in his endeavours wherever possible; and
- Restates its belief that domestic violence is unacceptable in all circumstances.'

(vi) Mr Tony Rooth (Shalford) to move under Standing Order 11 as follows:

'That this Council shares the concern of local residents and parents that a Public Sex Environment should not be allowed to exist in close proximity to Puttenham Church of England Primary School. This Council agrees to recommend to Cabinet that the Council owned lay-by on the A31 (which provides the major access to this sex site) should be closed as soon as possible.'
