

LOCAL CAPITAL ALLOCATION 2005/06

This report explains the background to the funding, how it has previously been used and recommendations for the forthcoming year.

1 INTRODUCTION AND BACKGROUND


- 1.1 The Leader of the County Council, in his budget speech, announced that the Local Capital Allocation will be £100,000 for 2005/06 to each of the Local Offices.
- 1.2 It is anticipated that, as in previous years, any under or overspend on this budget will roll forward to the next financial year. It is not yet known what the outturn will be for 2004/05.

2 2004/05 SUMMARY

- 2.1 Last year the Committee approved the funding to under take feasibility studies to sustain the LTP programme, with the remainder to be delegated to the Local Transportation Director to be used to address local priorities agreed at the Members' workshop.
- 2.2 County Members prioritised a number of schemes at an informal meeting in May 2004.
- 2.3 Feasibility work included the following:
 - A245 Stoke Road crossing option by Blundel Lane
 - Paramics model for East Molesey
 - Seven Hills speed limit changes
- 2.4 A total of £10,000 was used to provide new street lighting. In suitable locations this proves popular with residents and is a valuable contribution towards community safety.
- 2.5 The remaining budget has been used for the following small schemes:
 - Drainage repairs at Hurst Road, Ferry Tavern (Portsmouth Road), Mills Road, Monument Road, and Portsmouth Road j/w Couchmore Avenue.
 - A kerb build-out at Portsmouth Road j/w Claygate Lane on site imminently.
 - Footway reconstruction at Lebanon Drive on site imminently.
 - Winters Bridge footway resurfacing and bus stop improvements (under construction).


3 PROPOSALS FOR 2005/06

- 3.1 Traditionally the bulk of the Local Allocation has been used for transportation studies and environmental highway works.
- 3.2 The conservation area improvement at the junction of Bridge Road/Church Street, Weybridge (known as the Quadrant) has been designed and consulted upon and is ready for construction.



The scheme will be funded from this budget (\pounds 20,000) and from the Divisional Member's [lan Lake] budget (\pounds 14,000).

3.3 The Divisional Member for Hersham (Margaret Hicks) has in previous years funded the investigation and re-design of the junction of Queens Road, Molesey Road and Burwood Road. The introduction of a new roundabout should improve the record of this junction that has a minor safety problem. The proposals will also improve the pedestrian facility and produce a general improvement to the environment in the centre of the village.



- 3.4 Funding is also proposed to facilitate the further development of the Intermediate LTP scheme for Esher Green, and proposals for Walton High Street, the Weybridge 20 mph zone and speed limit changes to Woodstock Lane South, all of which are detailed in separate agenda items. There are also non-specific allocations to facilitate low cost traffic schemes and environmental improvement proposals that may come forward in due course.
- 3.5 A fixed allocation of £15,000 be made to the Weybridge Station Railway Bridge project for highway measures over and above those necessary for the Road onto Rail project.
- 3.6 A summary of the budget proposal is set out in Appendix 'A'.

4 CONSULTATION

4.1 Divisional Members will be advised when schemes start. Appropriate levels of consultation will be undertaken specific to each scheme.

5 FINANCIAL IMPLICATIONS

5.1 The Local Allocation is a capital works budget and can legitimately be spent in the proposed manner. The proposals include a predicted carry-forward from 2004/05, which is subject to Executive approval.

6 CRIME AND DISORDER IMPLICATIONS

6.1 All schemes will fully consider any implications to crime and disorder.
