# MEMBERS' ALLOCATIONS 2005/06 ANNUAL REPORT SURREY COUNTY COUNCIL

# LOCAL COMMITTEE (ELMBRIDGE) 3 JULY 2006

#### SUMMARY

Surrey County Council Local Committees receive delegated funding to allocate for locally determined purposes that meet local social, economic and environmental well-being.

This report provides a summary of how the Local Committee funding was allocated in 2005/06.

## 1. INTRODUCTION

- 1.1 Surrey County Council's Local Committees have been delegated power to take decisions in response to local needs within the County Council's power of well-being, up to a maximum sum per County Council member of the Committee. In addition the County Council has delegated a capital sum to Local Committees. This funding is determined annually as part of the Council's budget process.
- 1.2 In 2005/06, the County Council allocated the sum of £11,500 revenue per Member, and a total sum of £35,000 per Local Committee for capital projects. The Local Committee (Elmbridge) therefore had a total budget of £103,500 revenue and £35,000 capital to allocate throughout the year, as well as some funding which was carried forward from the previous year.

# 2. ANALYSIS AND COMMENTARY

- 2.1 Surrey County Council's Corporate Plan lists the main challenges for the County under the following headings:
  - Making Surrey a better place to learn and develop
  - Making Surrey a better place to live and do business
  - Making Surrey a better place to travel
  - Making Surrey a better place where vulnerable people are more independent
  - Making Surrey a better place where people feel safe
  - Making Surrey a better place where everybody matters
- 2.2 In line with the Corporate Plan, all member allocation expenditure (whether revenue or capital) is coded to reflect broadly how it aligns with corporate priorities. The codes are:

Adults & Community Care: independence for vulnerable adults, older people, adults with disabilities and health conditions, carers, health promotion Children & Schools: children, vulnerable children, play, parenting, schools, children with disabilities and health conditions, children's carers Community safety: street lighting, abandoned cars, graffiti, fires and rescue, road safety, consumer protection, drug and alcohol misuse, domestic violence, a sense of safety, fear of crime, reassurance.

Environment: protecting countryside, waste, recycling

**Transport**: ways to travel, roads, pavements, traffic problems, highways **Lifelong learning**: learning in the community, libraries, adult & community learning, schools as community centres.

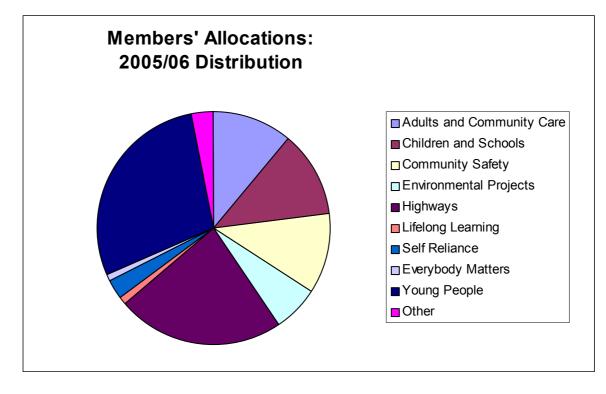
**Self-reliance**: local businesses, the Surrey economy, quality of life in disadvantaged areas, support for rural communities, ethnic minorities, community cohesion, refugees, management development for voluntary organisations

**Everybody matters**: consultation, community engagement, democracy, local committees, partnership development, publicity

**Young people** - facilities and activities for young people outside school including shelters, leisure equipment, courses, skateboard parks etc

2.3 The following charts show how both capital and revenue funds were allocated across these different subject areas, and indicates that projects to support highways and children and schools received the highest proportion of funding.
