In January, the County Council's Cabinet decided to advertise its intention to introduce parking charges in Elmbridge. Following this the Local Committee (Elmbridge) took part in the consultation and submitted its comments to the Cabinet for consideration. At the end of the consultation the Cabinet considered all the comments and made amendments to its proposals. The Transport and Environment Select Committee has called-in this decision, and the Local Committee has taken the opportunity to consider the new proposals and submit its comments to the Cabinet for consideration.

To ensure that it is listening to your opinions on this matter, the Local Committee has arranged to have a **40 minute question and answer session prior to its next formal meeting** so that residents have the opportunity to question Parking Officers with regards to the decision made by the Cabinet and how this would affect them as residents. These views would be listened to by Members of the Committee and would then be taken into consideration during the formal Committee meeting.

The Chairman has agreed that up to 10 questions can be submitted to be asked to the officers during the 40 minutes. So that we can get the broadest set of questions to the officers, **could anyone who wishes to ask a question, submit this to Michelle Collins by 9am Monday 20th June.** Michelle will then look at the submissions and put forward the 10 most popular questions to the officers, and identify someone to ask the question at the session.

So that this is a transparent process, all the questions submitted will be identified on the County Council's website (<u>www.surreycc.gov.uk/elmbridge</u>) from Tuesday 21st June. For this reason we request that you do not name individuals within the questions.
