8	Blenheim Road Household Waste Site	The Committee agreed: i) that a Traffic Regulation Order in accordance with the Road Traffic Regulation Act 1984 be advertised, the effect of which will be to close Blenheim Road to the north-east of the entrance to Surrey County Council's Household Waste Site on Saturdays, Sundays and <b>Bank Holidays</b> only, when appropriate traffic signs and barriers be displayed. Vehicular access to adjacent properties and access for pedestrians be maintained; and ii) that any objections received be considered by the Chairman in conjunction with the Local Transportation Director.

9	Safe Routes to Schools – Pedestrian Improvement Christ Church Mount	<p>The Committee agreed:</p> <ul style="list-style-type: none"> <li>i) that approval be given to design and construct a pedestrian scheme on Christ Church Mount outside Stamford Green Primary School as shown in Annexe 1;</li> <li>ii) that approval be given to advertise the proposed installation of road tables; and</li> <li>iii) that the Local Transportation Director be authorised to consider any objections received in response to the statutory notice in consultation with the Chairman of the Local Committee, and local Borough and County members.</li> </ul>
10	A2022 Alexandra Road, Epsom – Introduction of Waiting Restrictions	<p>The Committee agreed:</p> <ul style="list-style-type: none"> <li>i) that waiting restrictions and limited waiting parking restrictions shown in the plan attached as Annexe 1 be approved for introduction;</li> <li>ii) that authorisation be given to the making and advertising of the associated Traffic Regulation Orders; and</li> <li>iii) that the Local Transportation Director be authorised to consider any objections received in consultation with the Chairman of the Local Committee, and the local County and Borough Members.</li> </ul>
11	Decriminalised Parking Enforcement Agency Agreement	<p>The Committee agreed: That the Agency Agreement between Surrey County Council and Epsom and Ewell Borough Council, which was recently approved by the Borough Council, be approved.</p>

12	Annual Highway Management Plan 2005/06	The Committee agreed: i) that the Annual Highway Maintenance Plan for the Local Transportation Service, Epsom and Ewell 2005-06 be approved; and ii) <b>that it is regrettable that the total available funding is insufficient to meet all the outstanding maintenance needs of the Borough.</b>
13	Local Transport Plan – Transportation Capital Budget	The Committee agreed: i) the transportation schemes that form the Epsom and Ewell LTP programme for 2005/06; and ii) the progression of the transportation schemes in the programme be authorised.
14	Minor Highways/ Local Transportation Plan Scheme Progress Report	The Committee noted the report.
15	Flexible Forward Programme	The Committee noted the report.
16	Chairman's Report	The Committee noted the report.
17	Members' Allowances	The Committee noted the report.
