10/ EPSOM STATION APPROACH - PUFFIN CROSSING

1t was **RESOLVED** that the Local Committee gave authority to advertise the provision of a puffin crossing in Station Approach outside Epsom Station.

11/ EPSOM TOWN CENTRE PROPOSED TAXI RANKS

- **09** It was RESOLVED that the Local Committee.
 - i] noted the officers' reservations regarding the possibility of abuse of the proposed taxi ranks by drivers wishing to park;



- ii) noted the potential benefits for late night trade with the town centre
- iii] approved the proposals on the grounds it will help ease demand for taxi parking within the town centre and have no perceived negative impact on traffic movements or safety on the highway
- iv] proposed that this scheme be reviewed in one year's time.

12/ INTEGRATED TRANSPORT PROGRAMME [ITP] FOR 2009/2010 09 2013-2014

The Chairman proposed sending a Resolution to the Cabinet to note the concerns of the Local Committee on the overspend. A vote was taken [7 for and 3 against].

It was RESOLVED that the Local Committee send the following Resolution to the Cabinet:

The Epsom & Ewell Local Committee notes with concern the significant overspend on Highways works in 2008/2009. This appears to be due to having separate processes for estimating costs in advance and determining amounts chargeable after the work is complete. It understands that there are negotiations aimed at changing the system to one in which officers would be given fixed lump sum prices before the work is done. Whilst welcoming any improvement, it urges the Cabinet to ensure that any future process includes provision for comparing the rates charged to Surrey County Council with those currently being paid for similar work by neighbouring authorities.

It was RESOLVED that the Epsom & Ewell Local Committee

- i) noted the financial outturn for the previous financial year for Integrated Transport schemes (2008/09).
- ii) approved the programme of Integrated Transport schemes for Epsom and Ewell for progression in 2009/10, and in outline for 2010/2011 2013/14 funded by Local Transport Plan and Local Allocation budgets as set out within the report.
- iii) approved the Local Allocation of £100,000 for integrated transport schemes, as detailed within the report.
- lv] approved expenditure of £100,000 revenue funding in accordance with the details provided.

13/ CAPITAL AND MAINTENANCE PROJECTS PROGRESS REPORT

09 It was RESOLVED that this report be noted



14/ COMMUNITY SAFETY.

It was agreed that a correction to the report be noted under [1] Introduction and Background, 1.3, line 3 'strategy group' – should read 'Community Safety Group.'

It was RESOLVED that the Committee agreed:

- I] . The budget of £14,500 devolved to the Local Committee for community safety be transferred to the Epsom & Ewell Community Safety Group [CSG] to be spent to further the work of the Group, with £12,000 of this funding specifically reserved to fund work to reduce the incidence of domestic abuse locally.
- li] Nominate the Local Committee Chair's representation on the Local Strategic Partnership [LSP] and CDRP for the current municipal year. The Vice Chairman of the Local Committee to deputise in his absence.
- Iii] A report to the Local Committee will be presented at a future meeting to agree County Councillor representation on the LSP and CDRP Task Groups [health & well being, children & young people, business partnership, environment forum and education & lifelong learning], once the current review of partnership is completed and the new structure agreed.

15/ LOCAL PROTOCOLS FOR PUBLIC ENGAGEMENT

- 09 It was RESOLVED that the Epsom & Ewell Local Committee agreed the proposed local protocols set out in Annexe A to deal with public questions, and petitions to the Local Committee between 2009-2013, with the following amendments. [revised item 15 Annexe A attached].
 - i] Public Speaking at Meetings: addition to para 1 However, the Local Committee in Epsom & Ewell wishes to provide opportunities, where appropriate, for the public to express their views by asking written questions and attending the meeting to ask Informal Public Questions. The public is not allowed to engage in debate.

Ii] Public Questions

After the adjournment for Informal Questions, a member of the public can ask one question. After all who wish to have asked a question, at the Chairman's discretion, they can ask a further question, if there is sufficient time. The time available to ask Informal Public Questions is usually limited to thirty [30] minutes.

 - ii] To agree to adopt a process, as set out in Appendix 1 (para. 2), for agreeing small funding allocations (up to £1,000) outside of formal committee meetings, with approval delegated to the Area Director in consultation with members.
 - Iii] To approve the proposed expenditure from the Members' Allocations budget., for the Epsom Mental Health Week Cracking up, Clirs Colin Taylor and Chris Frost £1000 [£500 each].

It was RESOLVED that the Local Committee agreed the expenditure from the Members Allocations budget,

The proposal against the Capital Grant for the Lower Mole Countryside Trust – Land Rover appeal is to be deferred to the next meeting of the Local Committee.
