**09** There were no apologies for absence.

#### **56/ MINUTES OF THE LAST MEETING [item 2]**

**09** Minutes of the meeting held on 17 December 2009 were agreed

#### **57/ DECLARATIONS OF INTEREST [item 3]**

**09** Cllr Taylor declared a declaration of interest in Bradstock Road, Cllr Kington in Delaport Close and Cllr Wood in Queensmead Avenue.

#### **58/ CHAIRMAN'S ANNOUNCEMENTS [Item 4]**

**09** The Chairman advised that he would take the adjournment for informal public questions prior to item 5.

#### **59/ ADJOURNMENT**

**09** Several members of the public attended, and 3 informal questions were put to the meeting with responses from Officers present.

#### **60/ EPSOM & EWELL PARKING REVIEW – PHASE 4: CONSIDERATION OF FORMAL OBJECTIONS [item 5]**

**09** It was RESOLVED that the Local Committee [Epsom & Ewell] **agreed:**

l] The recommendations detailed in Annexe A for drawings 1,2,3 [Thorndon Gdns not Rd], 5,6,7, 10, 13, 14, 15, 16, 17, 18, , 21, 22, 23, 24,26, 27, 28, 29, 30, 31, 32, 33, 34, 35, 37, 40, 41, 42, 43, 44, 45, 46, 47, 48, 49, 51, 52

with the **following amendments agreed to drawings detailed below:**

a] Drawing no. 4 Andrews Close. The restriction should be implemented at a distance of up to 10m in either direction on College Rd to comply with Highway Code, and as shown on drawing in Andrew Close. Proposed by Cllr Taylor, seconded by Cllr Dallen

b] Drawing No. 8 – Stamford Green Rd– Implement only the proposed junction protection markings at the junction of Christ Church Rd and Stamford Green Rd. To extend 20m, southwards into Stamford Green Rd, 10m west along Christ Church Rd and eastwards to the start of the zig-zag marking at the pedestrian crossing. Omit all proposed restrictions in Church Side, Bracken Path, Bramble Walk and Stamford Green. Proposed by Cllr Taylor, seconded by Cllr Dallen.

c] Drawing no. 9 – Highfield Drive – to recommend proceeding with all double yellow lines except for those at the junction of Highfield Drive & Meadow Walk. To implement SYL restriction as shown in all areas, apart from a section on both side between Courtlands Drive and Meadow Walk. (the single yellow line to end opposite the end point of the DYL restriction). Reduce the proposed hours of operation to Mon-Fri 10-11am and 2-3pm. Proposed by Cllr Kington, seconded by Cllr Smith.

d] Drawing No. 11 – Jasmin Rd – to continue as advertised. To review the junction of Lavender Road and Jasmin Rd at a later date. Proposed by Cllr Mason, seconded by Cllr Taylor.

e] Drawing No. 12 –Manor Green Rd – To implement DYLS as advertised on the junction of Manor Green Rd and Christ Church Mount – extending as far as the rear of no.132 M/G/R. Implementing DYLS on the corner of Meadway (as shown on the drawing) and M/G/R (outside of no.141 M/G/R only). To reduce the length of the proposed DYLS in C/C/M, on the corner with the access to Drummond Gardens to stop at the eastern boundary of No. 71 C/C/M and at the North-eastern boundary of No. 1 Lower Hill Rd. To reduce the time period of the proposed DYLS west of the School Keep Clear Marking to 8.30-9.30am and 2.30-4.30pm. Proposed by Cllr Taylor, seconded by Cllr Mason.

f] Drawing No. 19 – St Normans Way – to implement only the junction protection markings – double yellow lines, and to look at further restrictions at a later date. Proposed by Cllr Wood seconded by Cllr Arthur.

g] Drawing No. 20 – Nonsuch Court To implement as advertised – amend the restriction in Arundel Ave to 11am – 12noon. Proposed by Cllr Wood, seconded by Cllr Arthur.

h] Drawing no. 25 – Gayfere Rd –to continue as advertised. Proposed by Cllr Wood, seconded by Cllr Arthur.

j] Drawing No. 38 – Manor Drive etc., To proceed with JPMs at the junction of Preston Drive and Bradford Drive – and those at the junction of Manor Drive and Preston Drive. To implement a section of the SYL opposite the DYL on Bradford Drive, [from nos. 1 –13] and change the hours of operation to Mon-Fri 8.30am – 5.00pm, and to look at further restrictions at a later date. Proposed by Cllr Kington and seconded by Cllr Arthur.

k] Drawing No. 39 – Providence Place – to continue as advertised. Proposed by Cllr Wood and seconded by Cllr Arthur.

ii] that the County Council makes amendments to existing traffic regulation orders and introduces new traffic regulation orders as necessary for the recommended parking controls to be implemented.

lii] That the recommended parking controls are implemented.

These recommendations were proposed by Cllr Colin Taylor and seconded by Cllr David Wood.
