



**OFFICER REPORT TO LOCAL COMMITTEE
(EPSOM & EWELL)**

SMALL DISADVANTAGED AREAS FUND 2010-2011

13th SEPTEMBER 2010

KEY ISSUE

For the Committee to decide which of the bids submitted should be recommended to the Small Disadvantaged Area Fund Panel for funding consideration.

SUMMARY

Local Committees have been asked to consider and prioritise bids submitted for funding within their borough, and recommend onto the Small Disadvantaged Areas Fund Panel those which it considers should be funded through the Small Disadvantaged Areas Fund.

Five separate bids have been submitted to the Local Committee for consideration. These bids have been assessed against the criteria set out in Annex A, and the results are set out in Annex B for information. Copies of the bid documentation supplied is attached under Annex C

OFFICER RECOMMENDATION

The Local Committee (Epsom & Ewell) is asked to:

- (i) Consider all the bids that have been submitted to the Local Committee;
- (ii) Prioritise them in order of those which best fit the criteria set out in Annex A; and
- (iii) Identify the bids the Committee would like to recommend to the Small Disadvantaged Areas Funds Panel for funding.

1 INTRODUCTION AND BACKGROUND

1.1 In May 2010, Dr Andrew Povey, the Leader of Surrey County Council, announced a new fund from the Project Initiatives Fund called the Small Disadvantaged Areas Fund.

1.2 In launching this fund, the Leader said that:

“The extent of borrowing undertaken by the previous government is such that there will inevitably be a reduction in public expenditure over the next few years. In Surrey, I feel it is important that we try to help some of our more disadvantaged areas to help themselves to develop economically, socially and in a way that is sustainable.

Projects could well take on board the "Digital Inclusion" work, which is one way of strengthening communities, but ideas and innovation are welcome!”

1.3 The purpose of the Fund was to develop initiatives which reduce inequalities and empower small to medium-sized communities in Surrey which experience relative disadvantage to work with the County Council and other relevant partners to develop local solutions to the problems facing them.

1.4 He requested that Local Committees assess the bids that were submitted for projects within their area, and decide which of the bids should be submitted for consideration by the central Small Disadvantaged Bids Panel for funding. The Panel would then meet in December to consider the recommendations, and a formal announcement of those that had been successful would be made at the Council meeting on 14 December 2010.

2 ANALYSIS

2.1 All projects that are being submitted to the Panel for consideration will be expected to have demonstrated the following:

- **Innovation:** model new ways of listening to residents (such as digital inclusion) and involving them in developing services, which meet the needs of their neighbourhood in a sustainable way.
- **Involvement:** work with residents, statutory partners and the voluntary/faith sector to embed increased confidence and cohesion in communities, which make a difference & can lead to sustained improvements in quality of life, opportunities and achievement.
- **Integration:** demonstrate genuine partnership working which pursues a shared vision (ideally through the relevant Local Strategic Partnership), operates with a “Total Place” methodology in terms of sharing resources and involves services adjusting their delivery to reflect local conditions.

2.2 They will also be required to show how they relate and contribute to County Council's five strategic themes

- Core Offer
- Personal responsibility
- Deciding and delivering locally
- Prevention
- Working together

2.3 In addition, the Local Committee are asked to look to recommend projects where the Committee can demonstrate that the projects have:

- Made progress in taking forward the principles of Localism and "Total Place".
- Developed a clear understanding of the profile of disadvantage in their district/borough.
- Evidenced multi-agency activity that responds to needs and opportunities in the most disadvantaged neighbourhoods.
- Addressed improvements in education, skills, tackling anti-social behaviour/vandalism and other social matters of concern.
- A continuing record of investment in projects or have an emerging focus of priority which could strengthen these neighbourhoods and increase the range of opportunities available to their residents
- The potential to deliver sustained capacity building in that community.

2.4 Five bids have been submitted to the SCC Local Committee Epsom and Ewell, in summary the bids comprise:

- **High Need Families – Amount requested £28,500**

Bid centred on addressing impact of child poverty through a focus on high need families within Court and Ruxley wards, two of the most deprived wards in Surrey. Funding sought toward a 'Team around the family Co-ordinator' to put in place a comprehensive support and intervention package. Co-ordinator to work across agencies with up to 8 families to join up services in a coherent manner to best address what can be a host of interdependent issues associated with high need families.

- **Support and Advice to Children and families experiencing Domestic Abuse – Amount requested £6000**

North Surrey Domestic Abuse Outreach Service Bid focused on offering support and advice to children and young people aged up to 16 who are witnessing domestic abuse within their families within Court and Ruxley wards. There are currently no services specifically targeted at children and young people. Parts of Court and Ruxley wards had more than double the rate for domestic violence in 2009 with 9.7 incidents per 1000 population compared to 3.6 as a whole.

- **Debt Advice & Outreach – Amount requested £7,500**

Epsom & Ewell Citizen Advice Bureau bid to extend the work of the part time debt advisor working in Court and Ruxley wards and to pursue development of outreach services possibly staffed by volunteers in order to make the service more accessible to a greater number of residents and families within these communities.

- **Health Champions – Amount Requested £2000**

Stronger Community Group Health led bid for funding to train two people within the Court and Ruxley areas of Epsom and Ewell to act as Health Champions. This work is in line with work being co-ordinated within priority places in Surrey. Training is an accredited course and will provide local people with the opportunity to gain health skills and to support their community to improve their health and to access health services

- **One Stop Shop – Amount requested £1885**

Bid by Community Involvement Coordinator, supported by the Stronger Communities Group for funding to pilot the opening of a space in the Longmead Community Centre on one day of each week from which to run a 'One Stop Shop'. The aim of the project would be to enable a range of agencies to provide a range of services and opportunities to residents via this facility, for example the space could be utilised for member surgeries or for quit smoking programmes to be held.

- 2.5 To support the Committee in assessing the bids against these criteria, Officers have carried out an initial assessment of each of the bids against the matrix set out in Annex B. Copies of the submitted bid forms are included in Annex C to this report.

3 FINANCIAL AND VALUE FOR MONEY IMPLICATIONS

- 3.1 All successful bids will be funded out of the allocated money within the Project Initiatives Fund. The essence of the project is that it is to provide communities with the ability to support them sustainably. Therefore there are no further financial implications.

4 EQUALITIES AND DIVERSITY IMPLICATIONS

- 4.1 The successful bids will support some of the more disadvantaged areas of Surrey to develop sustainable mechanisms to develop economically and socially.

5 CRIME AND DISORDER IMPLICATIONS

- 5.1 There are no identified crime and disorder implications at this time.

6 CONCLUSION AND RECOMMENDATIONS

6.1 The recommendation is that the Committee scrutinise and assess the bids submitted for consideration and recommend to the Small Disadvantaged Fund Panel those it would recommend for funding through this Fund.

7 WHAT HAPPENS NEXT

7.1 The Small Disadvantaged Fund Panel will consider all the recommended bids in December and formally announce the successful candidates at the Surrey County Council meeting on 14 December 2010.

7.2 The successful candidates will then have until March 2012 to utilise the funds as set out within their bid form and will have to report back the outcomes of their spend by June 2012.
