KEY ISSUE

The Forward Programme for the Local Committee for 2005/6.

SUMMARY

- 2) Consider and indicate further preferences for inclusion in the Forward Programme, 2005/6.

1 Introduction and Background

- 1.1 The Forward Programme of the Local Committee is revised at each Committee meeting. Members are requested to propose any additional items for inclusion on the Programme. Officers are then required to investigate and consult with the appropriate services, partners or other agencies on the purpose, content and timing of future reports. As these negotiations are concluded then items are added to the Programme.
- 1.2 Following SCC's Policy and Productivity Review, there are structural changes to both the Community Support Service and the Local Transportation Service. Until such changes are known, it is not clear what

the capacity of these services will be to support the work of the Local Committee. Further, SCC is conducting a Governance Review of Local Committees to review local ways of work as a committee, including the number and type of Local Committee meetings. As a consequence the focus and number of Local Committee meetings may be subject to consultation.
