As these negotiations are concluded then items are added to the Programme.

- 2 For 2006/07 the formal decision-making meetings of Local Committees are to be complemented by Members promoting up to 4 public engagement events of priority cross-cutting themes, where Standing Orders will not apply and a more two-way process with the public could be fostered. At the last meeting of the Committee it was suggested that 3 such meetings be held with the following themes:
  - Youth facilities and provision around Guildford borough
  - Waste and Minerals
  - Highway Maintenance
- 3 The first of these meetings will be held at 7pm on 6<sup>th</sup> November at Kings College in Park Barn, Guilford. Dates and venues for the other two meetings are to be confirmed.
