# **KEY ISSUE**

Member Agenda Planning Group, the Forward Programme has been revised to reduce the number of items and remove some items from the Programme, particularly items for information.

- 3. For 2006/07 the formal decision-making meetings of Local Committees were complemented by 2 public engagement events of priority cross-cutting themes, where Standing Orders did not apply and a more two-way process with the public could be fostered. It was suggested that 3 such meetings be held with the following themes:
  - ◆ Youth facilities and provision around Guildford borough held at 7pm on 6<sup>th</sup> November at Kings College in Park Barn, Guilford
  - ♦ Waste and Minerals held at 7pm on Thursday 25<sup>th</sup> January 2007 at East Horsley Village Hall
  - ◆ Highway Maintenance deferred from 8<sup>th</sup> March to 10<sup>th</sup> May (7pm at SCC Offices in Cross Lanes, Guildford).

Members are invited to suggest themes for future public engagement events in 2007/08.
