## SURREY COUNTY COUNCIL LOCAL COMMITTEE (GUILDFORD)

# 11<sup>th</sup> MARCH 2009

### <u>KEY ISSUE</u>

This report documents progress on the Minor Improvements programme over the past year and recommends a number of newly identified schemes for addition to the programme as recommended by the Members Task Group.

### **SUMMARY**

The Transportation Task Group met on 27<sup>th</sup> November 2009 to consider new requests for minor improvements and to review the existing minor highway improvements programme. The recommendations of the Task Group are set out in the report.

### RECOMMENDATIONS

The Committee is asked to agree:

- (i) that the progress made in delivering the minor improvements programme since last year be noted, including the completed projects set out in **ANNEXE A**.
- (ii) that the list of schemes remaining in the forward programme as set out in **ANNEXE B** be noted.
- (iii) that the recommendations of the Transportation Task Group regarding new schemes put forward since last year be approved as set out in **ANNEXE C**, supported by the detail in **ANNEXE D**.
- (iv) that officers be authorised to proceed with any necessary actions including traffic orders, advertisements and notices of intent in order to deliver these projects as soon as 2009/10 budgets are known.

### PROGRESS DURING 2008/2009

- 1 **ANNEXE A** sets out details of those schemes on which progress has been made since April 2008, funded from the 2008/09 LTP settlement.
- 2 **ANNEXE B** lists those schemes remaining in the forward programme, as yet unfunded, on which no work has yet been carried out.

### NEW REQUESTS FOR SCHEMES TO BE ADDED TO THE PROGRAMME

- 3 The Transportation Task Group met on the 27th November 2009 to review progress achieved on existing Minor Improvement Schemes and to consider new requests put forward since last year.
- 4 During the last year, 7 potential new improvements were identified by Officers, Members, Parish Councils and residents. The Transportation Task Group received a detailed presentation on each of these, including an assessment by officers of the opportunity each scheme provided to meet the needs of local communities and the Local Transport Plan (LTP) objectives. These schemes and the Officer and Task Group recommendations are shown in **ANNEXE C**. **ANNEXE D** also shows the detailed assessment considered by the Task Group for each such request.
- 5 Under normal circumstances this report would be (a) proposing schemes for addition to the forward programme, and (b) seeking agreement to a programme of schemes to be funded for the coming financial year. This year's circumstances are different in a number of respects:

- (a) The York Road / London Road junction improvement is behind schedule, and at the time of drafting the report officers have only an approximate cost estimate. This suggests that the cost may be substantially higher than initially predicted. Until the detailed Bill of Quantities and method statements are received it is not possible to determined whether this initial estimate is reasonable, or whether the scope of the works may need to be revisited. The scheme remains a high priority due to the accident rate at the junction.
- (b) Design resources within the West Area office were centralised in the autumn of 2008. This design pool was not fully staffed at the outset, although agency and consultant staff have subsequently been taken on. A number of the feasibility and design projects listed in ANNEXE A are behind schedule, although all but one have been commenced. Three are approaching the stage of consulting residents and other stakeholders.
- (c) There will be a change in contractual arrangements with the constructor partner with effect from April 2009, resulting in a move from the current arrangements to a fixed price or 'lump sum' basis for all future projects. There is therefore a need to allow the year end to pass in order to re-establish each project under these new arrangements.
- (d) At the time of drafting this report, officers have not been informed of the budgets available for minor improvements from either Local Transport Plan or Local Capital Allocation funds for 2009/10. That said, these are expected to be broadly similar to those for 2008/09.
- (e) Equally, it is not clear whether underspent funds will be allowed to be carried forward into the new financial year. In the past this has always been possible, but it has been suggested that projects funded from the additional £5 million which was released part way through 2008/09 may need to be completed before 31 March.
- 6 For all of the above reasons, there is more than sufficient work in hand, that delaying a decision about the programme for next year until the June meeting of the Committee will have no detrimental effects on the programme. In addition, with the County Council elections in June 2009, deferring this matter will enable any newly-elected Members to influence the forward programme.

### FINANCIAL AND VALUE FOR MONEY IMPLICATIONS

7 This report has no immediate financial implications. A further report will be presented at the next meeting of this Committee, once LTP budgets are known. This will recommend which projects should proceed during 2009/10.

### SUSTAINABLE DEVELOPMENT IMPLICATIONS

8 Each scheme has site-specific environmental & economic implications, which will be described in future reports as each project progresses.

### OPTIONS

9 The Committee may choose to accept or reject the recommendations of its Transportation Task Group.

### CONSULTATIONS

10 All schemes included in the forward programme will be subject to appropriate consultation as they are developed.

### EQUALITIES AND DIVERSITY IMPLICATIONS

11 This report has no implications for equality and diversity.

### **CRIME AND DISORDER IMPLICATIONS**

12 This report has no implications for crime and disorder.

### CONCLUSIONS AND REASONS FOR RECOMMENDATIONS

13 This report sets out the officer and task group recommendations for schemes to be included in the forward programme of minor schemes

14 A report will be brought, probably to the next meeting of this Committee, setting out the funding available and recommending which schemes should proceed in 2009/10.


