13. BARNETT WOOD LANE/WOODFIELD LANE, ASHTEAD [For Decision]

14. EAST SURREY RURAL TRANSPORT PARTNERSHIP (RTP) [For Decision]

Agenda item only

This Partnership was established in summer 2001 to tackle unmet transport needs in the East Surrey Health Authority area. Its initial focus will be on the three rural districts in East Surrey – Mole Valley, Reigate and Banstead, and Tandridge. Core members of the Partnership are: East Surrey Health Authority, Mole Valley District Council, Reigate and Banstead Borough Council, Surrey County Council and Tandridge District Council. The Partnership operates via an officer group comprising staff from each partner agency.

A successful application has been made to the Countryside Agency to part-fund an RTP officer for 3 years to develop and implement new rural public and community transport initiatives. The partner agencies have all promised match funding. The initial role of the officer will be to draw up a detailed three-year action plan which will be submitted to the Countryside Agency within six months. Any service developments proposed in the action plan will be the subject of further applications to the Partnership Fund, as has already been successfully achieved in West Surrey.

The primary objective of the Partnership is to improve accessibility to transport services in East Surrey for everyone who does not have ready access to public transport. This is a broader definition of community transport than traditional schemes, which focus primarily on those with mobility problems or social needs.

The appointment of the RTP officer is now under way, and once in post he/she will begin the six-month action planning process. The Committee is asked to decide if it wishes to be consulted once he/she has formulated some preliminary findings. This could be done by way of a workshop, probably in the early autumn.

15. FETCHAM, BOOKHAM AND EFFINGHAM LOCAL AREA SAFETY STUDY – MONITORING FINDINGS [For Decision]

Green

A review to determine the effectiveness of traffic calming and traffic management measures, introduced as part of the Fetcham, Bookham and Effingham (F.B.E) Local Area Safety Study has been undertaken.

The F.B.E Task Group has recently re-convened to discuss the findings of the study, which reviews the effectiveness of the scheme upon measurable targets, including personal injury accidents, vehicle speeds, traffic volumes and Heavy Goods Vehicle movements.

This report summarises these findings and requests approval to proceed with the development of further measures. These measures will be at locations where ongoing accident, and traffic problems have been identified. There are also some locations where residents' concerns over traffic-related issues still remain

16. CAPITAL BUDGET [For Decision]

This report details how the transportation capital budgets for 2002/2003 could be utilised following a Members Working Group to prioritise Local Transport Plan (L.T.P) Schemes within the Leatherhead and Dorking Implementation Areas. A thematic bid to secure funds for integrated transport measures has been made and the total amount of funds available for the District of Mole Valley for the 2002/3 financial year will be unknown until May 2002. There are however, funds available to the value of £250,000 which can be allocated to schemes within the two L.T.P implementation areas. In addition it is anticipated that members will wish to allocate the County Capital Local Allocation of £100,000 to highways and transportation schemes.

Members are requested to agree the priority order of schemes and projects and to agree the allocation of funds accordingly.

17. REVENUE BUDGET [For Decision]

18. B2038 PIXHAM LANE, DORKING – EXPERIMENTAL ROAD CLOSURE [For Decision]

At the July 2001 meeting of Mole Valley Partnership Area Transportation Committee, Members approved the advertisement of a Traffic Order necessary to implement an experimental closure of Pixham Lane.

Construction of the closure is currently programmed for May, however, some Members have expressed concern as to how the scheme could be judged effective or otherwise. It is consequently suggested that any Member of the original Pixham Lane Members Working Group (County Councillors: David Gollin, Mr. David K Timms and Mrs Hazel V A Watson; District Councillors: Mr Derrick Burt, Mr Derek Edge and Mr Ben Tatham) be entitled to request a reconvention of this Working Group at any point after an initial two month trial period, in order to review the operation and effectiveness of the road closure. Only upon conclusion of the Working Group could the road closure then be removed.
