# Questions from David Sharland, District Councillor for Leatherhead South

# Leatherhead High Street - parking

"Word is getting around that it is acceptable for motorists to park all day in Leatherhead High Street during the hours of 10am and 4.30pm provided the vehicle is not moved. During these hours the road is supposed to be pedestrianised. On a number of occasions the number of vehicles parked in the length of the High Street has exceeded twelve. This is a source of obstruction for the visually impaired. The drivers are behaving in an antisocial manner. What action is being taken to prevent this all day parking?"

# Leatherhead High Street – Traffic during pedestrianised hours

"Persistent questions have been asked regarding the access of vehicles into the High Street, Leatherhead during the hours when the area is pedestrianised. It is not unusual for traffic to be seen moving both up and down the High Street despite it being one way. Despite promises no action has been forthcoming to prevent traffic moving during the prohibition hours. Should there be an accident involving a pedestrian and vehicle what is the County's position? Has a risk assessment been carried out? When will action be taken to prevent this traffic entering the High Street during the prohibited hours?"

# Question from Rosemary Dickson, District Councillor for Leatherhead South

### A243 Car Park

The car park on the A243 (by the AA lay-by and just before the Knoll roundabout) is in a very poor state of repair. The height barrier was crashed into about seven years ago. It is twisted and at an angle. It looks dangerous and certainly unsightly. The car park itself is very unkempt. There is also an unlicensed flower stall on the roadside beside the car park. This site gives a very poor first impression of the area.

Can you tell me when this car park is likely to receive some attention, when the barrier will be fixed and what you intend to do about the flower stall?

#### **Response:**

There are no plans at the present time to do anything to the car park on the A243. The Area Director would be keen to resolve the future of the car park but has yet to seek the views of Members and other interested parties.
