

# CAPITAL PROJECTS

# Local Committee for Mole Valley 21 June 2006

#### **KEY ISSUE:**

To note the progress of schemes and to receive the outturn figures for the 2005/06 financial year and to update the Committee's capital allocations for schemes planned for the 2006/07.

#### **SUMMARY:**

This report provides an update on the progress of schemes during 2005/06 **Annex A** and gives the outturn figures for the end of the 2005/06 financial year.

The Committee, at its meeting in December 2005, agreed in principle the funding of its capital works implementation programme for 2006/07. **Annex B** of this report updates the capital allocations associated with the Committee's planned implementation programme for 2006/07.

The Committee's implementation programme is constrained by the available resources and is also subject to the Executive agreeing to carry-forward budget variations from 2005/06.

The report concludes that the 'Base Figure' allocations for Local Transport Plan and Local Allocations, together with a carry-forward from 2005/06 would enable the implementation programme for 2006/07 to be progressed as anticipated.

#### **OFFICER RECOMMENDATIONS:**

#### The Committee is asked to

- i. note the progress of schemes undertaken during 2005/06 (Annex A) and the outturn figures for 2005/06; and
- ii. agree the capital allocations (Annex B) for the Committee's implementation programme for 2006/07.

#### 1.0 INTRODUCTION AND BACKGROUND

- 1.1 The Committee agreed in principle at its meeting on 15 December 2005, to the funding of its capital schemes for 2006/07, as set out in Annex D of that report. The Committee also noted that firm recommendations on the level of funding for 2006/07, would be brought to this Committee early in the new financial year.
- 1.2 The Committee received a report at its meeting in July 2005, which set out the implementation programme for 2005/06. **Annex A** to this report provides a summary of schemes in progress during 2005/06. Funding for those schemes not yet complete will be necessary during 2006/07 and it is anticipated that the Executive will confirm carryforward budget variations at their meeting on 20 June 2006.
- 1.3 **Annex B** to this report updates the Committee's capital allocations associated with its planned implementation programme for 2006/07.

#### 2.0 ANALYSIS AND COMMENTARY

#### 2005/06 Implementation Programme

- 2.1 Progress with the implementation of the Committee's 2005/06 programme of works has been mixed during the last financial year.

  Annex A shows the latest position with the Committee's 2005/06 capital programme. Whilst progress has been made in all aspects of the programme, certain works have been delayed in either design and or construction. Unforeseen difficulties encountered on-site during the progress of schemes have had to be resolved and eliminated.
- 2.2 The schemes currently awaiting completion are being progressed and it is anticipated that the Executive will agree at their meeting on 20 June 2006, to carry-forward budget variations from the 2005/06 capital allocations.
- 2.3 The financial outturn figures for 2005/06 reflect the mixed successes achieved in implementing the Committee's 2005/06 programme of work.

#### 2006/07 Implementation Programme

2.4 The Committee agreed in principle the financial allocation for its 2006/07 programme of works (Local Transport Plan and Local Allocation) at its meeting in December 2005. That outline programme has been refined and **Annex B** gives more detail about the work to be undertaken during 2006/07.

#### 3.0 CONSULTATIONS

3.1 Annex B contains schemes previously agreed by the Committee; no specific consultation took place in this instance.

#### 4.0 FINANCIAL IMPLICATIONS

4.1 The outturn figures for 2005/06 in Table 1 below reflect the mixed success in delivering the Committee's programme of works during 2005/06.
