**RESPONSE TO THE PETITION
CONTROLLED PARKING ZONE DORKING**

11 JUNE 2008

KEY ISSUE

To consider the petition submitted by Mrs. Hill on behalf of the residents of Dorking to the possible introduction of a Controlled Parking Zone.

SUMMARY

The petition was presented to oppose the introduction of a Controlled Parking Zone (CPZ) in the Dorking area.

OFFICER RECOMMENDATIONS

The Local Committee (Mole Valley) is asked to agree that:

- (i) the petition is noted, and the Committee be referred to the formal decision of the 12 March 2008, agenda item 12 that:

withdraw major Controlled Parking Zone (CPZ) in Dorking.

1 INTRODUCTION AND BACKGROUND

- 1.1 The Committee agreed to progress the Controlled Parking Zone (CPZ) in Dorking at the Local Committee meeting on 21 March 2007.
- 1.2 The draft Controlled Parking Zone (CPZ) proposals were produced in October 2008, with an informal consultation carried out over the following 2 months.
- 1.3 The Controlled Parking Zone (CPZ) proposals were met with mixed support from residents.

2 ANALYSIS

- 2.1 The petition submitted to the Local Committee on 12 March 2008 and with additional signature pages collected up to 29 March 2008 showed over 2000 signatures opposing the Controlled Parking Zone (CPZ) in Dorking.

3 OPTIONS

- 3.1 There are none.

4 CONSULTATIONS

- 4.1 Through the local committee process of 12 March 2008.

5 FINANCIAL IMPLICATIONS AND VALUE FOR MONEY

- 5.1 The cancellation of the scheme at the Informal Consultation Stage will stop any further spend.
- 5.2 All work carried out to date will be archived for future use.
