- 5) Reduce carbon footprint by reducing food miles
- 6) Promote a sense of community
- 7) Demonstrate the value of self reliance and the possibilities this creates as a contribution to reducing climate change

We expect the outcomes to be full occupancy of the plots available, a thriving, productive, sociable Society and the production of quality locally grown produce for local people. We have support from a local farm shop who have offered to provide excess seedlings free of charge and have indicated they will buy back surplus produce from the allotments.

Q6 How will you measure your success in carrying out the activities and achieving the outcomes you have set out above?

Obtain planning consent (initial correspondence with planners are very encouraging);

Complete digging over of site and installation of pestproof fencing before initial planting;

Achieve full occupancy of the 24 plots;

Construction of secure storage facilities and shelter;

First harvest:

- 1) Document the outcome of first harvest in terms of range and amount of produce achieved across the allotments as a whole.
- 2) Encourage local press to cover the success of the initiative
- 3) Updates on appropriate web sites, particularly 'CGG'
- 4) Hold at least two social/fundraising events per year.

Enable building of essential infrastructure – ie. secure stock fencing to protect site from straying animals and rabbits, onsite storage facilities, shelter and toilet facilities.
