What is it and where do children's centres fit in?

It is a multi agency plan based on the five outcomes of Every Child Matters and on the National Service Framework for children, young people and maternity services.

Although not a blueprint for the delivery of services, the plan sets a strategic framework for all services to work together, identifying priorities, areas for improvement and ways to change.

Two of the 8 key priorities highlighted in the plan that are fundamental to the success of children's centres are:

- Access to integrated local services
- Increased influence of children' young people and the families on the design and delivery of services and local decision making.



Targets for Surrey - 50 Children's Centres by 31st March 2008

Phase 1 – 4 centres. Phase 2 – 46 centres

- areas 1-10 inclusive Full Core Offer reflecting need and level of existing service
- 36 Graduated Offer to reflect the needs of the community

Full Core Offer

- Integrated early years provision
 - Integrated education and childcare for a minimum of 48 weeks per year, 10 hours per day, 5 days per week.
 - Childminder's Network
- Family support, parenting education and parental outreach
- Child and family health services
- Parental involvement
- Education, training and employment services including links with Job Centre Plus
- Access to wider services

Minimum level of service

Centres will have a role in the coordination of integrated services provided through outreach, as part of the LA framework for children's services.

Minimum level of service to be provided:

- Information on childcare and early years provision
- Information and support to access wider services
- Information and advice to parents
- Support to childminders
- Drop in sessions or early years provision
- Links to Job Centre Plus and health services

Who decides the level of service?

- Surestart Unit outline the range of integrated services to be provided for the full core and graduated offer centres and agree any variations on an individual basis.
- Local Authority evidence the level of offer to be provided after the mapping of local need, existing services and in consultation with the local community.



On what basis does the Local Authority make that decision?

- The proportion of families with children under five in the local population living in income deprived households
- The proportion of families with children under five in the local population with significant special needs
- The extent to which existing childcare providers meet parents' needs
- The prior existence of accessible services in the local area to meet the support needs of families with children under five.
