



## **OFFICER REPORT TO LOCAL COMMITTEE (REIGATE AND BANSTEAD)**

### **REIGATE AND BANSTEAD PARTNERSHIPS NOMINATIONS AND DELEGATED POWERS**

**21 JUNE 2010**

#### **KEY ISSUE**

Surrey County Council is a statutory partner on the Reigate and Banstead Local Strategic Partnership (LSP) and on the Reigate and Banstead Crime and Disorder Reduction Partnership (CDRP). The Local Committee has been delegated £14,500 annually to support the work of the CDRP. This fund is delegated to the Area Director, and spent in consultation with the County Council's representative on the CDRP, according to the Community Safety Strategy priorities.

#### **SUMMARY**

The Local Committee has a role in influencing and contributing to community planning in Reigate and Banstead and in planning for effective crime reduction initiatives particularly in relation to funding contributed by Surrey County Council towards the local crime prevention programme.

#### **OFFICER RECOMMENDATIONS**

**The Local Committee (Reigate and Banstead) is asked to:**

- (i) Nominate a County Councillor to the Reigate and Banstead Local Strategic Partnership.
- (ii) Nominate a County Councillor to the Reigate and Banstead Crime and Disorder Reduction Partnership.
- (iii) Agree that the Area Director, in consultation with County Councillor representative, agree the allocation of Surrey County Council community safety funding allocated to the CDRP, in accordance with the Community Safety Strategy priorities.

## **1 LOCAL STRATEGIC PARTNERSHIP AND THE COMMUNITY PLAN**

- 1.1 Under the Local Government Act 2000 local authorities were given a duty to prepare a Community Strategy in partnership with the community, statutory organisations, businesses and the voluntary sector. The Community Plan for Reigate and Banstead is a vision for the borough through to 2020.
- 1.2 The purpose of the plan is to set out a long-term vision and to devise a strategy for areas where partnership working is needed to improve quality of life according to the needs and wishes articulated by the community. The plan is therefore 'owned' by all members of the LSP, who are responsible for its development and implementation. Members from the borough and county council sit on the LSP; the member role is to champion the plan, lend specific support to projects and feedback information to members of the Local Committee as appropriate.
- 1.3 Reigate and Banstead has a well-represented Local Strategic Partnership (LSP), chaired by the Leader of Reigate and Banstead Borough Council, meeting four times a year. A significant amount of work goes into each priority between meetings, with partners working together to achieve agreed targets.
- 1.4 The vision for the borough, as identified in the community plan, is that Reigate and Banstead will be one of the most desirable and attractive areas in the region. It will be a place where:
  - People who live, work and visit the borough enjoy the benefits of a prosperous economy
  - Neighbourhoods are renewed, improved and supported by effective service, infrastructure and transport options
  - The wellbeing of communities is supported by accessible health, leisure, education and information services.
  - People enjoy active, healthy and diverse lifestyles and take personal responsibility
  - The environment and green space is maintained and enhanced for the future
- 1.5 The Local Committee has a role in influencing and contributing to the community plan for Reigate and Banstead by nominating a County Council representative to sit on the LSP.

## **2 CRIME AND DISORDER REDUCTION PARTNERSHIP**

- 2.1 The Local Committee has delegated authority over a small budget of some £14,500 of Surrey County Council funding contributed towards addressing local areas of concern in relation to Community Safety.

- 2.2 A Surrey County Council Member sits on this partnership group, to contribute to the debates and influence decisions, which will affect local residents in Reigate and Banstead, and to report back to the Local Committee at regular intervals to keep committee members fully informed of progress.

### **3 OPTIONS**

- 3.1 The Local Committee has an influencing and monitoring role on the work of the LSP and on the CDRP. It can note and comment on the Community Plan and it can also influence the decisions of the CDRP.
- 3.2 The Borough Council also has a significant role in the Community Plan and in Community Safety and there are recommendations under consideration to pilot closer working between the local authorities at Member level.
- 3.3 Members can further the work of each of these bodies by nominating a County Member who will effectively represent the best interests of the County and of the local residents of Reigate and Banstead.

### **4 CONSULTATIONS**

- 4.1 The Community Plan for Reigate and Banstead was subject to widespread consultation. Residents are consulted via a regular survey on all matters pertaining to Community Safety.

### **5 FINANCIAL AND VALUE FOR MONEY IMPLICATIONS**

- 5.1 There are no financial implications with regards to the LSP. The CDRP funding is held in common with the other partners and decisions are taken as a group on how it should best be spent. This is done with particular attention to value for money.

### **6 EQUALITIES AND DIVERSITY IMPLICATIONS**

- 6.1 Any future consultation with local communities will consider how to engage with hard-to-reach and minority groups within the community.

### **7 CONCLUSION AND RECOMMENDATIONS**

- 7.1 Surrey County Council is the statutory partner on the LSP and on the CDRP.

**The Local Committee (Reigate and Banstead) is asked to:**

- i. Nominate a County Councillor to the Reigate and Banstead Local Strategic Partnership.
- ii. Nominate a County Councillor to the Reigate and Banstead Crime and Disorder Reduction Partnership.
- iii. Agree that the Area Director, in consultation with County Councillor representative, agree the allocation of Surrey County Council community safety funding allocated to the CDRP, in accordance with the Community Safety Strategy priorities.

- 8.1 The Local Committee's service monitoring role and devolved budgets provide an excellent opportunity for supporting the work of the LSP and the CDRP.

- 9.1 The Surrey County Council member representative(s) will attend the Local Strategic Partnership (LSP) and/or the Crime and Disorder Partnership meetings, and will support and enable county involvement on the targets of the LSP/CDRP and feedback to members with the Area Director at Local Committee on a regular basis.
