RBBC/SCC DRAFT AGREEMENT – PEOPLE AND PLACES

This Agreement sets out the basis upon which the Surrey County Council and Reigate and Banstead Borough Council will work together to improve the quality of life of various communities in the Borough and co-operate on service delivery through the Surrey First programme.

The Councils have agreed to work together on these issues and to establish a Joint Committee, which will oversee progress and submit proposals for its establishment for approval by each Council. The Joint Committee will rationalise existing arrangements and increase local empowerment.

The Joint Committee will be established in accordance with Local Government Act powers and be authorised to act on the behalf of the Parties in determining the joint action and how Council will contribute to delivering agreed outcomes. Joint officer teams will be considered for key priorities led by one or the other council by agreement.

The Councils will no later than *********, seek authority, in accordance with its own governance provisions, to establish the Joint Committee. The terms of reference of the Joint Committee shall provide for it to direct: -

- oversee the delivery of agreed outcomes associated with the regeneration of Redhill, Horley, Preston and Merstham
- the delivery of new forms of waste collection and disposal services in the Borough to increase recycling levels, reduce waste to landfill and reduce carbon emissions from the overall operation;
- improved joint working to deliver better operational services e.g.
 - the provision of on and off street parking services in the Borough;
- joint action to maximise private developer funding for priority infrastructure for example work on mitigation of growth in LDF
- joint action to identify and bid for other sources of funding for priority infrastructure
- joint action to deliver priority infrastructure in a coordinated and timely way
- joint strategic planning to ensure that town planning policies and asset management are coordinated to ensure delivery of priority infrastructure

- the implementation of the Surrey First priority work streams including for example: working together to develop a new data centre together with Surrey Partners.
- collaboration on services that improve the quality and cost effectiveness of the street scene for example highways, street cleansing, parking
- joint action to sustain and improve economic competitiveness

Reigate and Banstead Borough Council will provide secretariat support for the Joint Committee.

The long term vision for the improvement in the following areas is set out below together with deliverables both Councils are committed to seeking to achieve over the next 5 years.

HORLEY

The regeneration of Horley town centre needs to be co-ordinated with the development of the new neighbourhoods as it is essential to provide a social, cultural and commercial centre to cater for the proposed 30% increase in Horley's population.

Growth will be focused on the two new neighbourhoods of the North East and North West Sectors through their comprehensive development, which will be integral with the existing built-up area of Horley and ringed by a riverside green chain of public open space. Access and transport connections to the town centre need to be improved and the town regenerated by making it the focus of high quality commercial, retail, community and residential developments to meet the current and future needs of local people. This will secure its future vitality and viability and, together with public realm improvements make it a pleasant place to be.

Local people will be empowered to develop their skills, confidence and self-esteem. Public and voluntary service providers will pursue opportunities to deliver shared services to maximise local benefits

PRESTON

The achievement of the vision, objectives and outcomes relies on the funding commitments made by and effective collaborative working between the two Councils and key partners such as the Raven Housing Trust. In particular to secure funding from the De Burgh School site and other new development for improvements identified in the Masterplan.

REDHILL

The vision for Redhill is to provide a thriving town centre serving as a prominent commercial location, a competitive retail destination and associated housing. Redhill needs to make the most of its excellent local and regional transport links and accessibility to stimulate growth and encourage movement by a full range of sustainable transport choices.

The town centre needs to provide a range of services and facilities to satisfy the demands of a growing population and workforce at all times of the day. This should include new shops to improve the town's retail offer, enhanced cultural provision and the creation of a family-focused evening economy.

The town centre should be a safe, people-friendly and desirable place to be, with the creation of a network of active, varied and attractive public spaces

with links to a wider network of accessible, multifunctional green spaces, meeting the needs of all age groups.

The Councils will work together to maximise the level of recycling and reduce the level of land fill in the Borough and develop the Surrey First waste initiative.

We will also work together on a joint project to deliver an integrated waste / recycling and processing centre at Earlswood based on the sites owned by the two Councils.

CAR PARKING SERVICES

The Councils will work together (in partnership with other East Surrey Authorities) to produce a financially viable on street parking service which meets the needs of the town centres and car users in the Borough, supports parking enforcement across Surrey more widely and which reduces operating costs and generates additional income that will be invested in highways infrastructure improvements.

FLOOD MANAGEMENT

To collaborate to make most effective use of collective resources to implement the Flood and Water Management Act 2010.

ECONOMIC DEVELOPMENT

To collaborate and make most effective use of collective resources to sustain and improve economic competitiveness.

STREET SCENE

To collaborate and make most effective use of resources to improve the street scene.

TRANSPORT

To jointly plan improvements to transport infrastructure, identify funding and coordinate delivery.

OTHER INFRASTRUCTURE

To jointly plan improvements to other infrastructure, identify funding and coordinate delivery.

ASSET PLANNING AND TOWN PLANNING

Strategic planning to align town planning policies with asset management to deliver priority infrastructure.
