(REIGATE AND BANSTEAD)**

**PROPOSED ON-STREET 'PAY AND DISPLAY' PARKING
CHARGES IN REIGATE AND BANSTEAD -
LOCAL COMMITTEE CONSULTATION**

28 FEBRUARY 2011

KEY ISSUE

To provide comment and feedback for the Surrey County Council Cabinet about proposed on street parking charges in Reigate and Banstead Borough.

SUMMARY

On the 12 January 2011 the Cabinet Member for Transport approved a consultation programme for the introduction of on street pay and display parking charges in Surrey. As part of this consultation process each Local Committee is being asked for its views on the proposals. These will be reviewed and reported to the Cabinet to assist in the decision making process.

OFFICER RECOMMENDATIONS

The Local Committee (Reigate and Banstead) is asked to provide comment and feedback about the proposals for on street parking charges in the Borough to help the Cabinet decide how to proceed.

1 INTRODUCTION AND BACKGROUND

- 1.1 Surrey County Council is the Highway Authority in Surrey and responsible for managing the highway network including on-street parking. Reigate and Banstead Borough Council act as agent for Surrey and carry out enforcement of the on street parking restrictions in the Borough as well as managing their own off street car parks.
- 1.2 On the 12 January 2011 Ian Lake, Cabinet Member for Transport approved a programme of consultation for the introduction of on street parking charges in many towns and shopping areas around Surrey. This report is attached as **Annex 1**. A revised recommendation was approved at the meeting and is shown in **Annex 2**.

2 ANALYSIS

- 2.1 The benefits and issues associated with on street parking charges are described in the Cabinet Member report (Annex 1).
- 2.2 In order to report the Local Committee's views and investigate their comments about these proposals it would be beneficial for the Local Committee to consider each of the locations where the introduction of on street parking charges is proposed and decide:
 - Whether they support the introduction of parking charges in each location.
 - If not, what are the reasons?
 - If yes, are there any changes that should be made to either the operational times or proposed tariff?

These views can then be reported back to the Cabinet.

3 CONSULTATIONS

- 3.1 It is proposed to carry out a statutory consultation and advertise the proposals in Reigate and Banstead during late February and March 2011. Notices will be placed in local newspapers and on street where changes are planned. Local chambers of commerce will also be contacted.

4 FINANCIAL AND VALUE FOR MONEY IMPLICATIONS

- 4.1 Currently, Surrey County Council runs a deficit of approximately £500,000 across the County in the management and enforcement of on street parking restrictions. The Reigate and Banstead Parking Enforcement Team made a surplus of £19K in 2009/10, however in recent years parking enforcement has run at a deficit ranging from £28K to £64K. This effectively reduces the funding available for highway

maintenance. On street car parking charges could contribute to eliminating this deficit, and potentially increase the funding available for highway maintenance and improvements.

- 4.2 A more detailed breakdown of the likely income and running costs associated with on street pay and display parking in Reigate and Banstead Borough is shown in **Annex 3**.
- 4.3 Any income raised from on street parking charges must by law be spent on highway improvement or environmental works under Section 55 of the Road Traffic Regulation Act.
