## **KEY ISSUE**

#### 19 June 2012

- **The Community Right to Challenge** to approve Surrey's Community Right to Challenge policy
- **Taking Public Health Forward in Surrey** the report will summarise progress to date on the Public Health Transfer and seeks Cabinet approval for the planned approach and way forward to be taken during the coming months

#### 11 July 2012

New Salting and Snow Clearance Services Contract (Part 2 report)

 to approve the appointment of a new Salting and Snow Clearance Services contract

#### 19 July 2012

• **New Primary School in Horley** – to consider whether to approve publication of the first statutory notice inviting proposers to submit proposals in a competition to establish a new one form entry primary school in Horley in September 2014

### 24 July 2012

- Local Sustainable Transport Fund to approve the headline programme for the financial years 2012/13 to 2014/15 of the Local Sustainable Transport Fund (large bid) and to accept the Grant Fund Award for up to £16m from the Department of Transport. To note the detailed annual draft programme and plan for each of the towns will be agreed by the relevant Local Committee
- Public Value Review Surrey Library Service: Community Partnered Libraries – to re-take the decision of Cabinet on 27 September 2011, which was quashed by the Judicial Review – to agree that libraries provision in ten libraries (including Tattenhams) is delivered via the Community Partnership model
