This approach is made in the knowledge that maintenance work along the traditional route of the Black Cherry Fair procession could impair the unrestricted viewing of that vital ingredient to the success of the Fair, which is Chertsey's major community event and largest fund-raiser for charitable causes. During the procession, collections are made for the various charities and so the continuous unrestricted viewing by local residents is a necessity."
