# LOCAL ALLOCATION 2007/08

# 12 MARCH 2007

## KEY ISSUE & SUMMARY:

To appraise Members of the situation regarding the 2006/07 Local Allocation programme and to agree the expenditure for 2007/08.

## **OFFICER RECOMMENDATIONS**:

The Committee is asked to agree the programme as shown at Annex B.

#### 1. INTRODUCTION & BACKGROUND

1.1 The Local Allocation for Spelthorne for 2007 / 08 is estimated at £100,000 which is to be confirmed. It is anticipated that unspent funding from 2006 / 07 will be rolled forward to 2007 / 08.

#### 2. ANALYSIS & COMMENTARY

- 2.1 The current situation regarding the projects and schemes agreed by this Committee during 2006 is shown at **Annex A.**
- 2.2 The funding to provide cycle facilities and bus waiting facilities is mostly unspent due to reduced staff resources. The other schemes are either complete or underway.
- 2.3 The funding to investigate the provision of a Controlled Parking Zone for Staines will need to be met from S.106 monies because the Local Allocation funding should always produce an asset. It is possible that the investigation into a CPZ would not result in an implemented scheme.
- 2.4 The proposed programme of projects and schemes is set out at **Annex B.** Cycle facilities and bus waiting facilities have been rolled forward. The programme of posters and interactive signs is on-going and further work is required on the Clockhouse Lane pedestrian / cycle bridge.
- 2.5 The introduction of a southbound weight restriction on Clockhouse Lane and the locations for amendments to waiting restrictions are considered elsewhere on this agenda.
- 2.6 Requests for the provision of mobility ramps and disabled drivers' parking places are frequently received. During the last eight months 41 requests for the provision of disabled drivers' parking places have been received, of which only 3 failed to meet our criteria. The budget for new works would enable speed limit roundels and other small roadmarking schemes to be implemented swiftly.

#### 3. FINANCIAL IMPLICATIONS

3.1 The programme for the Local Allocation for 2007 / 08 commits the year's available funding but does not account for any funds that are rolled forward from 2006 / 07.

#### 4. SUSTAINABLE DEVELOPMENT IMPLICATIONS

4.1 The planned work programme is directed to achieve the Local Transport Plan objectives and targets.

#### 5. CRIME & DISORDER IMPLICATIONS

5.1 The programme endeavours to achieve the objectives of the Crime & Disorder Reduction Strategy for Spelthorne.

#### 6. EQUALITIES IMPLICATIONS

6.1 There are no implications arising from this report.

#### 7. CONCLUSION & REASON FOR RECOMMENDATION

7.1 A programme of a wide range of schemes and projects is proposed in order to continue works in support of the Local Transport Plan.
