It consists of two County Members (the Chairman and Mr Burrell) and two Borough Council Members and officers from both authorities. Following corporate advice Local Committees are being told to give any of their Task Groups terms of reference. This report is to seek Members' approval to terms of reference for the Partnership which will not have any Executive power.
