97108 APOLOGIES FOR ABSENCE (Item 1)
Apologies for absence were received from Mr Davies, Mr V Agarwal, Mr L Burrell and Councillors Sider, Trussler and Grant.

98/08 MINUTES (ITEM 2)
The Minutes of the meeting held on $16^{\text {th }}$ March 2009 were confirmed as an accurate record and signed by the Chairman.

99/08 DECLARATIONS OF INTEREST (ITEM 3)
Councillor Packman declared a peronal interest in respect of item 5, as resident of Ashford.

100/08 CHAIRMAN'S ANNOUNCEMENTS (ITEM 4)
It was noted that there were no public or member questions as it was a special meeting and, having checked with democratic services, it was advised that questions did not need to be included.

101/08 REVIEW OF REQUESTS FOR AMENDMENTS TO WAITING RESTRICTIONS (ITEM 5)

The Local Highways Manager outlined amendments to waiting restrictions to help address current difficulties that were being experienced by residents, businesses and schools. Mrs Saliagopoulos asked if the member for Ashford had been consulted and if the restrictions related to safety. The Local Highways Manager confirmed the restrictions were related to safety and further consultation by public notice would be made and any input would be welcomed.

Councillor Forsbrey asked if there was any enforcement of white lines outside No2 Village Way, Ashford. The Local Highways Manager confirmed that white lines outside a house were not enforceable.

It was proposed by Mrs Saliagopoulos and seconded by Councillor Forsbrey that the amendments to Annexes A and B be made:

To add an item 3 to Anomalies, Annex B:
Location: Gresham Road, Staines. Problem: AAT restrictions proposed to be implemented summer 2009 will leave a gap of day time restrictions.
Proposal: Extend AAT to join taxi rank
To add item 4 to Anomalies, Annex B :
Location: Budebury Road, Problem: Access difficulties
Proposal: Extend AAT to o/s Budebury Court and No 11.
Subject to the above amendments being made the following recommendations were agreed

## Resolved:

(i) the 23 highest priority locations on the list of requests for amendments to waiting restrictions as shown at Annex $A$ and the amendments shown at Annexes $B \& C$ be advertised by public notice;
(ii) subject to no objection being received these restrictions be implemented;
(iii) if an objection was received before the end of the objection period, it be determined by the Local Highways

Manager in consultation with the Chairman, the Local Electoral Division Member and the Leader of the Borough Council; and
(iv) the implementation of the amendments be funded from the Local Allocation 2009 / 2010 at an estimated cost of £25,000.
