#### **PUBLIC QUESTIONS**

#### Mrs Marian Rough asked the following question:

"Would the appropriate department please reconsider making Monday evening available to the Staines Target Club as the limitation to Sundays only has severely damaged the viability of this organisation in membership and financial areas. This organisation thrived (some original youth members are current members) in the Leacroft location since 1965 until the arbitrary decision last year to alter the venue and time usage. This decision makes no sense whatsoever as Leacroft has remained unused for the entire year on Monday evenings.

The retention of this club in this venue is considered of high importance by the Borough Councillors of all parties because this Olympic sport is open to all wishing to participate irrespective of age, disability and gender of Surrey residents."

#### The Area Manager, Youth Development East gave the following answer:

"The current licence for the use of Leacroft by the Staines Rifle and Pistol Club (SRPC) expires on 1st November 2009, any requested changes to the day and times of use should be part of the discussion between SRPC and SCC regarding potential renewal of the licence. The Youth Development Service would be sympathetic to allow the change of the day of use from Sunday to a Monday, provided the appropriate break clause was built into the licence in order to allow the service to claim back Monday evenings when the development of youth work at Leacroft demands it "

#### Mr Robert Watts asked the following question:

**"BROADLANDS GRANGE GREEN LANE SHEPPERTON** 

# DRAFT

As the local highway manager would you investigate the following at this new development?

1 Damage to footways following the removal of the site hoarding as the footings encroached into the public highway.

2 That the new low-level metal boundary fencing recently erected has encroached into the highway with the post footings.

3 That the original access points with dropped kerbs are removed and reinstated to match the existing highway.

4 That any other damage to the highway is repaired prior to the development opening.

Please ensure that all work carried out on the public highway has been approved in advance by your department to ensure that all risk assessments are in place including proper traffic management."

# The Local Highway Manager gave the following answer:

"I apologise for not responding to you. These matters are under investigation by Surrey Highways in liaison with Surrey County Council Legal Services and I will respond to you when I have further information."
