  To be presented by Mr Andrew Lodge Petition with 4,520 signatures which reads "We the undersigned,

petition SCC to abandon plans to impose parking restrictions and charges on the residents within Ashford Middlesex in Church Road and surrounding areas for the following reasons:

We consider that your proposals will significantly damage the Town and surrounding streets for the following reasons:

- Local businesses struggle for survival due to the development of local 'superstores' (Tesco and Sainsbury) and therefore need stimulation for growth rather than further restriction. The deterioration of Church Road is marked by the continuing surge of 'charity shops'.
- Parking restrictions in Church Road will simply drive parking into unrestricted areas such as those streets which adjoin Church Road. This will adversely affect those residents within those areas.

It is understood that monies raised by this project will go to SCC and not be returned to rejuvenate an already deprived area. Therefore on the face of it this appears to be simply a money-making project for SCC.

At present Ashford Town Centre parking manages without the intervention of SCC and such intervention will be resented by residents and businesses alike."
