2.0 LOCAL COMMITTEE REVENUE ALLOCATION

2.1 Table 2 provides an overview of how the £100,000 revenue budget has been allocated. It should be noted that the new highways maintenance contract provides for areas of work such as drainage and lining, however the locally allocated sum is available to top up budgets where local priorities for funding differ from countywide priorities.
