Members' Allocations Out turn report for 2003 /04 and Allocations for 2004 / 05

SURREY COUNTY COUNCIL'S LOCAL COMMITTEE IN SURREY HEATH

29th April 2004

KEY ISSUE: To inform Members of the Allocations made in 2003 / 04 and to update Members on this financial years Allocations.

OFFICER RECOMMENDATIONS:

That the Surrey Heath Local Committee:

- 1. Note the out turn report for 2003 / 04
- 2. Note the level of funding available,
- 3. Note that ALL allocations must be made by October 2004,
- 4. Agree to pool £7,000 per Member into a central fund for 2004 / 05.

MEMBERS ALLOCATIONS FOR 2003 / 04

- 1. The out turn report for Members' Allocations made in 2003 / 04 is contained in the Annex to this report.
- The Surrey Heath Local Committee had a total of £109,277.50 to allocate locally in 2003 / 04. Each Member had £17,850 to allocate. Members decided to pool £10,000 each into a central fund of £60,000. This left £7,850 (plus carry over from 2002 / 03) for each Member to allocate personally.
- Local Committee Allocations are recorded as falling into one of nine possible categories. These are: Adults & Community Care: independence for vulnerable adults, older

people, adults with disabilities and health conditions, carers, health promotion **Children & Schools**: children, vulnerable children, play, parenting, schools, children with disabilities and health conditions, children's carers **Community safety**: street lighting, abandoned cars, graffiti, fires and rescue, road safety, consumer protection, drug and alcohol misuse, domestic violence, a sense of safety, fear of crime, reassurance. **Environment**: protecting countryside, waste, recycling **Transport**: ways to travel, roads, pavements, traffic problems, highways **Lifelong learning**: learning in the community, libraries, adult & community learning, schools as community centres.

Self-reliance: local businesses, the Surrey economy, quality of life in disadvantaged areas, support for rural communities, ethnic minorities, community cohesion, refugees, management development for voluntary organisations

Everybody matters: consultation, community engagement, democracy, local committees, partnership development, publicity

Young people - facilities and activities for young people outside school including shelters, leisure equipment, courses, skateboard parks etc

MEMBERS ALLOCATIONS FOR 2004 / 05

- 5. The agreed criteria are that:
 - The project is legal and is able to show a clear audit trail.
 - The project will be completed **before** the end of the financial year.
 - The funding needed is a "one-off".
 - The funding will support the priorities of the Surrey County Council Corporate Plan, the Surrey Heath insert of the Corporate Plan or the Surrey Heath Community Strategy. (See below)
 - The project will give long-term benefit.
 - The project will be preventative in nature.
 - The project will be of benefit to the wider community
 - The project targets disadvantaged areas or groups.
 - Surrey County Council funding will unlock more funding opportunities.
- 6. Surrey County Council's Corporate Plan lists the main challenges to be met under the key areas of:
 - Making Surrey a better place to learn and develop.
 - Making Surrey a better place to live and do business.
 - Making Surrey a better place to travel.

- Making Surrey a better place where vulnerable people are more independent.
- Making Surrey a better place where people feel safe.
- Making Surrey a better place where everybody matters.
- 7. The key issues identified by the Surrey Heath Local Strategic Partnership are:
 - Health
 - Housing and Employment
 - Transport
 - Safety
 - Community Support
 - Education
 - Environment
 - Leisure
- 8. County Council Members will have received a report entitled "Mid-Term review The Way Forward". This suggested that for the next two years County Council priorities should be:
 - Improving the local street scene.
 - Working with Young People to develop facilities for them.
 - Making every pound count, and keeping the Council Tax rises as low as possible.
 - Demonstrating we are able to be both truly local, and big enough to handle the major issues, standing up for Surrey's residents.
 - Ensuring that people know what we are doing.
- 9. Members' Allocations for this financial year are £12,500 per Member. It is suggested that each Member contribute £7,000 to the pooled budget. This will leave each Member with £5,500 to allocate individually.
- 10. The Local Committee also has £35,000 of capital funding this year to allocate to the voluntary services.
- 11. In order to ensure that funding can be allocated and used within this financial year it is important that Members decided on allocations by October 2004. This will ensure that all allocations are finalised before the run up to the elections in 2005.

12. Consultation events undertaken in 2003 / 04 were funded from the central budget and so were not subject to Members Allocation funding.
