## Footpath 113 (Chobham)

In the absence of a reply to my e-mail queries regarding the standard of the proposed alternative route and its future management I am lodging a formal objection to this public footpath diversion order, on behalf of the society whose land this footpath joins.

The proposed new route is currently too narrow and bordered by a poorly maintained fence with barbed wire. There is no public benefit in the proposed diversion.

Similar diversion of footpath 5 in Woking has resulted in the path becoming unkempt and difficult in the wet compared with when it ran in an open field maintained by grazing. The open aspect of a walk through a field is lost when it is penned in by fencing.
