Finally could contractors not cause obstructions to vehicles at junctions as this would cause safety issues at the junction of Winding Wood Drive and Upper Chobham Road.   |

| Mr Hughes                                     | 152, Upper<br>Chobham Road | Believes that the scheme would be a waste of money as there is a perfectly good footway on the other side.   |
| Mrs S, Crane                                  | 159, Upper<br>Chobham Road | She lives on the bend near to Carwarden House School and therefore believes it is a good idea as it is particularly dangerous at this point. Thinks we should have a look at the 40mph sign near this location as it is almost directly afte the children crossing sign which she believes is wrong.   |

Is in favour of the scheme but concerned about the sightline at the junction of Winding Wood and Upper Chobham Road as the residents built a new fence and replanted trees which obscures visibility  |

Would like a measure introduced outside Ravenscote School to prevent vehicles mouting the pavement. An idea would be bollard or raised pavements that would need to be extended as far as The Fairway  |
| Mrs R Shirley                                 | 131a Upper<br>Chobham Road | Thinks that it is a good idea although additional items need to be thought through first. Believes it would be better to traffic calm the road first as the 40mph signs are not enough of a deterrent. Having another footway will only encourage more cars to park on it especially when Ravenscote finishes, this makes it dangerous for pedestrians. In addition if vehicles are parking on this footway it will cause obstructions to driveways and inconvenience residents along Upper Chobham Road, bollards would therefore be a useful addition. Has concerns if vegetation is to be lost along the road The crossing points around the Prior Road junction with Upper Chobham Road roundabout are inadequate. A controlled crossing point between Winding Wood and Goldney Road would therefore be beneficial. Wate bins should be introduced along the route as a new footway would create a litter problem. |
| Mr Pearcey                                    | 21, Goldney<br>Road        | Believes that the proposal is an excellent idea. Suggested adding a pedestrian crossing at the bottom of Upper Chobham Road near Ravenscote School or round the corner in Old Bisley Road. Footway access to The Ridings or Holly Avenue from Byron Avenue would be another good idea.   |
| Mr Booth                                      | 32, Robin Hill<br>Drive    | Gives full support to the scheme bearing in mind the pedestrian movements along Upper Chobham Road. Requested that we consider reducing the speed limit to 30mph as people exceed the existing limit which is especially dangerous near the bend by Carwarden House School. This will only get worse when the new flats are built on the 136 Upper Chobham Road site   |
| Capri   | 139, Upper<br>Chobham Road | Would like some form of guard fence to ensure safety bearing in mind a lot of the traffic exceeds the speed limit particularly around the bend by Carwarden House School. Also need to consider double yellow lines on both sides of the road. The guard fence will also prevent parking on the footway.   |

In addition there is a telephone mast that looks into the back garden. He would like this moved metres towards Winding Wood as it will have to be moved anyway in order to fit the path in.  |

| Mr Ian Wilson                                 | 143, Upper<br>Chobham Road | Has concerns that a narrow pavement will cause children to step into the road, children will continually be crossing the road to meet friends, children will cross before the supervised crossing to avoid waiting, parents will now park on both pavements, traffic travels fast along the road particularly around the bend - children stepping out at this point will only increase the risk - barriers should therefore be considered at this point. Is concerned that the removal of greenery will expose poorly maintained fences. Does not want the street light opposite the property removed. May be worth spending the money on a proper controlled crossing near to Winding Wood.   |

A footway on both sides of the road will only encourage parking on both sides therefore blocking the visibilit from her driveway. Is also worried about the trees and shrubs that will be removed as these improve the environment and nulify the noise from school children.   |
