#### INTRODUCTION and BACKGROUND

- 1. Members allocations for 2005 / 06 were £11,500 per Member. Members agreed to pool £6,500 from each Member into a central fund.
- 2. The agreed criteria in 2005/06 were that:
- The project is legal and is able to show a clear audit trail.
- The project will be completed **before** the end of the financial year.
- The funding needed is a "one-off".
- The funding will support the priorities of the Surrey County Council Corporate Plan, the Surrey Heath insert of the Corporate Plan or the Surrey Heath Community Strategy. (See below)
- The project will give long-term benefit.
- The project will be preventative in nature.
- The project will be of benefit to the wider community
- The project targets disadvantaged areas or groups.
- Surrey County Council funding will unlock more funding opportunities.
- 3. Surrey County Council's Corporate Plan lists the main challenges to be met under the key areas of:
  - Making Surrey a better place to learn and develop.
  - Making Surrey a better place to live and do business.
  - Making Surrey a better place to travel.
  - Making Surrey a better place where vulnerable people are more independent.
  - Making Surrey a better place where people feel safe.
  - Making Surrey a better place where everybody matters.

- 4. The key issues identified by the Surrey Heath Local Strategic Partnership are:
  - Health
  - Housing and Employment
  - Transport
  - Safety

- Community Support
- Education
- Environment
- 5. Members will have received a report in 2004 entitled "Mid-Term review The Way Forward". This suggested that for the next two years County Council priorities should be:
  - Improving the local street scene.
  - Working with Young People to develop facilities for them.
  - Making every pound count, and keeping the Council Tax rises as low as possible.
  - Demonstrating we are able to be both truly local, and big enough to handle the major issues, standing up for Surrey's residents.
  - Ensuring that people know what we are doing.


#### 2005/06 Outturn

- 6. In 2005/06 Members allocated £104,583.85 out of a total budget of £104,699.37. The under spend of £115.52 was due to a project coming in under budget after the last Local Committee meeting of 2005/06. This budget included £35,000 of Capital funding.
- 7. In 2005 / 06 Members Allocations were allocated to the following areas:


Children and Schools	43392	40.50%
Other	20584	19%
Community Safety	16500	14%
Young People	10584	10%
Adults and Community Care	9533	9%
Self reliance	6060	6%
Environmental projects	850	1%
Highways	440	0.50%

8. Other includes work to community buildings and projects where the whole community can benefit eg sports grounds.

9. The graph below shows the split between revenue and capital funding in each category.



10. Geographical spread of Members Allocations in 2005 / 06. The chart below sets out a breakdown of whether Members' Allocations have been spent on initiatives that benefit the whole borough, or primarily one division. For the purposes of this chart the capital and revenue funding have been taken together. It shows that over a third of the funding used for the benefit of people living within the borough of Surrey Heath, with the remaining 63% focussed more locally within each of the Members' divisions. The Old Dean and St Michael's are the two main self reliance areas in the Borough and so funding for these specific areas has been shown separately.
