COMMUNITY SAFETY IN SURREY HEATH (amended)
19th October 2006

KEY ISSUE:

The report provides an update on the work of the Safer Surrey Heath Partnership. It incorporates local and comparative crime data and information on recent initiatives including neighbourhood policing. Borough and police partners have also contributed to the report and will attend the meeting to answer questions.

SUMMARY:

Surrey is the county with the lowest recorded crime figures in England, and Surrey Heath is the second lowest Borough in Surrey in terms of recorded crime levels. There has been a 2.5% increase in overall reported crime figures for the borough since last year.

The Safer Surrey Heath partnership has made a good start in the first year of its 2005-8 Strategy, and continues to work productively to promote community safety and reduce levels of crime and fear of crime in this area.

Funding for the Crime and Disorder Reduction Partnership (CDRP) last year (2005-6) included:

£157,000 from the Government Office South East;
£24,000 from the County Council;
£16,000 from the Police and Police Authority;
£22,000 from the Borough Council,
£2,000 from the Primary Care Trust.

OFFICER RECOMMENDATIONS:

INTRODUCTION AND BACKGROUND

1. The Safer Surrey Heath Partnership is comprised of representatives of six agencies: Surrey Police, Surrey County Council, Surrey Heath Borough Council, Primary Care Trust, Surrey Fire and Rescue Service and the Police Authority. This Crime and Disorder Reduction Partnership (CDRP) is statutory under the Crime and Disorder Act 1998, and was established to tackle crime and disorder by auditing and monitoring local incidences of crime, and working together to devise and deliver an effective strategy to deal with it.
2. All services contribute to the crime and disorder agenda, in line with Section 17 of the 1998 Act, which requires local authorities to mainstream crime and disorder by ensuring that all services have regard to the community safety implications of their activities.
3. In April 2006 the Local Area Agreement between Surrey County Council and the Government took effect. This distributes funding via the county to partnerships to deliver a number of priorities, most notably an overall reduction in crime county-wide of 13.2% by March 2008. The Safer & Stronger Communities Board, chaired by the Chief Constable, oversees delivery of the key outcomes in the Agreement and receives progress reports on local CDRP activity. The target for Surrey Heath is to reduce total crimes reported by 11% by March 2008.
4. In 2005 the Safer Surrey Heath Partnership devised and agreed a new strategy for the period 2005-8 with a number of new targets. These targets have been agreed with the Government Office of the South East (GOSE) and are detailed in Annex 2.
5. The borough level CDRP is assisted in delivering its targets by the work of two important multi-agency meetings:
 - the Joint Action Group (JAG), which meets monthly to review local hotspots for anti-social behaviour and to agree actions to tackle the behaviour;
 - the Community Incidents Action Group (CIAG), which meets monthly to monitor individuals who have come to the notice of agencies because of the impact of their behaviour on the community, and to agree service interventions to bring about improvements in their behaviour (which may include Anti-Social Behaviour Orders).

ANALYSIS AND COMMENTARY

6. Surrey is the safest county in England (based on recorded crime figures in 05/06 and 04/05). Changes in the way crime is defined and reported mean that trends are difficult to plot, however, the comparative trend is a positive one.
7. Crime in Surrey Heath rose slightly in 2005/06 by 2.5%. Although this figure was up slightly on 04/05, it was still lower than in previous years. There were 4376 recorded crimes in Surrey Heath in 2005/06. The most frequent crimes were Theft and Handling, Criminal Damage and Violence Against the Person (17% of which were Domestic Abuse), this followed the trend of the last five years. The crime data for Surrey Heath in 2005 / 06 compared to previous years, as well as additional crime figures to date are in Annex 1.
8. Total violence against the person rose by 24.9%, this was primarily due to changes in Home Office recording requirements which saw public order and harassment offences included as violence and continued proactive policing of crimes categorised as violence.

9. Total sexual offences also rose by 17.8%, however the numbers of reported offences are low and so this large percentage rise reflects an increase of only 8 cases. Much of the rise is due to an increased willingness to report incidents of this nature.
10. Fraud and forgery increased by 9.4% and does tend to change with seasonal variations. Year to date in 06/07 Surrey Heath has seen a reduction of 35%.
11. Total robbery decreased by 22.7% although the numbers of reported offences are low and so this large percentage reflects a decrease of only 5 cases.

PROGRESS TOWARDS THE 2005-8 STRATEGY

12. The Local Committee received details of the Partnership's Crime and Disorder Reduction Strategy 2005-8 at a meeting in September 2005, when the document had been recently published. Since the targets were put in place, there have been a number of new developments and projects, which are expected to contribute to achievement of the targets by the end of the three years. The strategy is based on the audit of crime statistics and the fear of crime survey, and incorporates the wider priorities set as part of the strategy and funding criteria by the Government of the South East (GOSE). The 2005/08 Safer Surrey Heath Strategy priorities and targets are in Annex 2.
13. In the past year the CDRP has provided a substantial amount of funding for local projects, details on projects are in Annex 3.
14. The Surrey Together initiative came into being last autumn, and is a partnership between Surrey County Council, the Surrey Police Authority and Surrey Police. Teams which comprise Police Community Support Officers (PCSOs), a sergeant, a youth development adviser and a trading standards officer are deployed in areas where there have been persistent reports of disruptive or nuisance behaviour by young people. Their role is to form relationships with young people to find out what lies behind their behaviour and to offer positive referrals to employment and training advice or to drugs counselling services. The North West Surrey Together team has been deployed in Frimley Green and Lightwater in recent months, as well as in parts of Runnymede and Woking. The Joint Action Group advises on where the team should be deployed.
15. It is estimated that out of a million active offenders in the UK, 100,000 offenders have three or more convictions and are responsible for half of all crime. In March 2004, the Government announced an end to end strategy to address this group of offenders. There is now a North West team based in Woking tackling Persistent and Prolific Offenders (PPOs) and leading on ASBO case building. Surrey Heath has only four PPOs, two of whom are serving custodial sentences; this level is low compared to other Boroughs.

NEIGHBOURHOODS PATHFINDER

16. North West Surrey is a pathfinder area for the Home Office's neighbourhood policing initiative, which is due to be rolled out nationally by April 2008. The pathfinder began in autumn 2005. Its aim is to "create confident, safe and secure neighbourhoods where people know that the police and partners understand the issues that matter most to them and are able to tackle them together" (Surrey's Neighbourhood Policing Programme Implementation Plan). This is to be achieved by putting in place a dedicated team of uniformed police officers and community support officers in every neighbourhood, to focus on low-level crime and anti-social behaviour.

17. The NW Surrey Basic Command Unit of Surrey Police (BCU) monitors and develops neighbourhood policing in its area. In Surrey Heath, there are nine neighbourhood clusters each of which has named officers (see Annex 4 map and Annex 5 contact details), co-ordinated and tasked by Surrey Heath Neighbourhood Inspector, Mark Adams. Residents are encouraged to contact their local officers by telephone or email, or in person at surgeries and panel meetings held in local venues, to let them know about problems or activities in their street or park (to find out who are their neighbourhood officers, residents can view the internet site www.surrey.police.uk and click inside the inter-active map for their area).
18. As well as speaking directly to their neighbourhood policing team, residents can highlight local concerns to the Surrey Police Authority at the Police and Community Participation Group (PCPG) meetings. The next meetings in Surrey Heath have yet to be confirmed.
19. The Police have put in place a system of Neighbourhood Panel Meetings. At these regular meeting local people are invited to come along and talk to their NSO and PCSO about local issues. At each meeting the key local issue is identified and the Police Officers commit to looking into this issue and reporting back at the next meeting. More information including issues raised and future dates are in Annex 6.

FUTURE WORKING

20. The NW Basic Command Unit area, led by Chief Superintendent Sue Warren, has worked together in recent months, for example to monitor and tackle Prolific and Priority Offenders (PPOs), and it is expected that divisional level working to share best practice and undertaken joint work will continue to develop. Prolific and Priority Offenders are an identified minority of offenders who are responsible for a disproportionate level of crime and disorder.
21. The Home Office are introducing the number 101 as a single non-emergency number, particularly for calls to report anti-social behaviour. A project team from Surrey Police, Surrey County Council, and all Districts and Boroughs are working on the implementation, which is scheduled to be by June 2007.
22. The neighbourhood policing approach will continue to develop, and to inform how partners work together with police to share expertise and ideas.
23. The Safer and Stronger Board, established to monitor progress on the Local Area Agreement, will continue to be a significant player in working with the CDRPs to channel funding towards practical measures which lead to real improvements.

REPORTING AND CONTACT

24. Residents with a serious crime to report should always contact 999, the emergency number, and ask for police.
25. Residents who wish to report a less serious but significant crime or act of anti-social behaviour may contact their neighbourhood police officer by telephone or email (see police website or Annexes 4 and 5 for details). Surrey Police's single non-emergency contact number, if residents are unsure who to contact in the first instance, is 0845 125 2222.
26. A further option to report anti-social or nuisance behaviour is by using the government website: www.direct.gov.uk/mycouncil. This allows the user to identify the problem they wish to report and to connect via a link directly to the relevant borough or county service.

27. As detailed in para 21, from 2007 there will be a national telephone number for reporting anti-social behaviour.

CONSULTATION

28. The Standing Citizens' Panel for Surrey Heath were consulted on community safety at their last meeting on 21st September 2006. The main issues of concern were:

- Distraction burglary
- Violent crime
- Police funding
- Camberley Train Station
- Theft of number plates
- Car Parks
- Drugs
- Anti-social behaviour
- Community Integration

Due to the weekly presentation of these figures, recorded crime figures relating to current and previous 28 days will not exactly match the number of recorded offences that Surrey Police provide the Home Office on a monthly basis. These figures are subsequently published annually by the Home Office in their [criminal statistics bulletins](#).

The figures presented reflect those entered onto the Surrey Police Crime database between the dates chosen. As a result of potential delays in the public reporting crimes to the Police, some of the crimes may have actually been committed before the chosen time period.

2005/08 Safer Surrey Heath Strategy priorities and targets

Reassurance

To reduce the fear of becoming a victim of crime.

To increase the awareness of success in reducing crime and disorder.

Anti-Social Behaviour

To reduce the number of complaints of anti-social behaviour and therefore local residents fear of crime.

Violent Crime

To reduce the level of violent crime.

Domestic Abuse

To increase the awareness of domestic violence and encourage victims to seek help and support.

To reduce the number of repeat victims of domestic violence.

Casualty Reduction

To increase the awareness of road safety issues and reduce the level of people killed or seriously injured.

Alcohol and Substance Misuse

To increase the awareness about substance misuse.

CDRP funded projects in 2006 / 07

The Partnership's Community Strategy 2005-08 outlines 13 main aims to enable the residents of Surrey Heath to be, and feel, safer in their communities. These aims are:

1. Reduce the fear of becoming a victim of crime
2. Increase the awareness of success in reducing crime and disorder
3. Reduce the number of complaints of anti-social behaviour
4. Reduce the level of violent crime
5. Increase the awareness of domestic violence and encourage victims to seek help and support
6. Reduce the number of repeat victims of domestic violence
7. Increase the awareness of road safety issues and reduce the level of people killed or seriously injured
8. Increase awareness about substance misuse
9. Increase access to treatment for the users of drugs
10. Reduce the level of alcohol related crime
11. Reduce overall levels of crime
12. Increase local communities' participation in local decision making
13. Develop the role of the Community Incident Action Group in relation to prolific and persistent offenders as well as other persons having a disproportionate community impact.

- *Police Drug Focus Team – £14,000, contribution towards staff costs*

This funding is to cover the cost of a dedicated officer for Surrey Heath, who gathers intelligence and sets up operations. It meets Aim 8 – to 'increase awareness about substance misuse'.

- *Life Education Centres - £16,500, schools work*

This organisation visits local schools to teach young people about the long-term effect of substance misuse on the body. It meets Aim 8 – to 'increase awareness about substance misuse'.

- *Sanctuary Scheme - £8,000, equipment*

This project enables people experiencing domestic abuse to remain in their homes by providing a 'sanctuary' room with reinforced doors and a panic button where they can go in case of emergency. It meets Aim 6 – to 'reduce the number of repeat victims of domestic violence'.

- *Alcohol Intervention Worker - £19,000, contribution towards staff costs*

This project makes a worker available to provide short term intervention work with people that have been arrested for offences such as violent crime and vandalism, where the offences have been committed under the influence of alcohol. It meets Aim 10 – to 'reduce the level of alcohol related crime'.

- *Arson Intervention projects - £3,300, contribution towards equipment and staff costs*

This comprises two projects – the first to provide a dedicated member of staff to carry out profiling work to better predict and manage arson attacks. The second project provides bicycles to allow fire fighters to access areas such as heathland where it is not appropriate to use other vehicles due to the sensitive nature of the wildlife habitats. It meets Aim 11 – to 'reduce the overall levels of crime'.

- *Reassurance projects - £16,500, contribution towards staff and publications*

This covers a range of initiatives being undertaken to raise the profile of the Partnership, and consequently reduce the fear of crime experienced by residents. These include work with the media, publications such as the Community Safety Strategy itself, and

campaigns. It meets Aim 2 – to ‘increase the awareness of success in reducing crime and disorder’, Aim 5 – to ‘increase the awareness of domestic violence’ and Aim 7 to ‘increase the awareness of road safety’.

- *Community Incident Action Group - £23,250, contribution towards staff and intervention*

This multi-agency action group works to identify, target and provide interventions for people who are causing disruption within the community. Agencies involved include Education and the Mall as well as Children’s Services, the Police and the Council. It meets Aim 13 – to ‘develop the role of the Community Incident Action Group in relation to prolific and persistent offenders as well as other persons having a disproportionate community impact’.

- *Policy work - £10,000, contribution towards staff costs*

A member of staff has been employed to work with the Partnership to further develop its effectiveness, and to monitor progress and advise on decisions and future action accordingly. In addition to a broader remit of helping the partnership to focus on priorities, it contributes to Aim 2 – to ‘increase the awareness of success in reducing crime and disorder’ and Aim 12 to ‘increase local communities’ participation in local decision making’ (in relation to community safety).

- *SNAP Disco – cost neutral*

The SNAP disco is run by Crimestoppers, the Council and the Police, in order to give young people a safe place to socialise whilst being targeted with information about drugs and other community safety issues. As the disco charges a small admission fee, it is financially self-sustaining. It meets Aim 8 – to ‘increase awareness about substance misuse’.

- *Police Community Support Officers - £15,000, contribution towards staff costs*

In Surrey Heath, each of the nine neighbourhoods now has one dedicated Police Constable, and at least one dedicated Police Community Support Officer. This allows better relationships to be built between the Police and the residents, increasing reporting of crime, greater reassurance, and enabling faster and more locally-informed response to incidents. It meets Aim 1 – to ‘reduce the fear of becoming a victim of crime’.

- *Youth Café - £7,500, project costs*

The youth café provides a safe environment for young people to meet and socialise in the town centre. It is based at the Good Taste Café in Camberley. Costs include subsidising the staffing/ general costs of the café itself, as well as the provision of County Youth Development Workers to provide advice and information to the young people in attendance. It meets Aim 3 – to ‘reduce the number of complaints of anti-social behaviour’.

- *Voices Project - £10,000, consultation and engagement*

This project seeks to give young people a platform to express themselves through a series of arts-based activities. It is hoped that this facilitates a greater sense of community, and gives decision-makers an insight into the aspirations of younger residents. It meets Aim 12 – to ‘increase local communities’ participation in local decision making’.

- *Domestic Violence Outreach - £32,000, staff costs*

The domestic violence outreach service is provided by Surrey Women’s Aid, and supports people experiencing abuse at home. It meets Aim 6 – to ‘reduce the number of repeat victims of domestic violence’.

- *Multi-Use Games Area - £46,500 (provisional), equipment*

The multi-use games area would comprise a hardstanding or artificial pitch, with goals and hoops to allow a range of different sports to be played upon it. It is intended that this will help to alleviate the boredom faced by young residents, and the numbers of complaints received regarding young people 'hanging around'. Much of the activity will be led by Police Community Safety Officers. It meets Aim 3 – to 'reduce the number of complaints of anti-social behaviour'.
