MEMBERS' ALLOCATIONS

8th March 2007

KEY ISSUE

To set out the funding available for County Councillors' allocations for 2006/07, and consider requests received.

SUMMARY

This report lists and makes recommendations on bids received for Members' Allocations that have been sponsored by at least one Member.

BACKGROUND

- 1. The budget available to Members is £66,000 of revenue funding to be spent on local projects to promote the social, environmental or economic well-being of the people of Surrey Heath. This amounts to £11,000 for each County Member of the Committee. An additional capital allocation of £35,000 has been made available to each Surrey County Council Local Committee.
- 2. The current allocations are set out in Annex A to this report, together with the balance remaining to be spent.

3. At the Local Committee meeting on 18th July 2006 Members agreed to pool £5,000 each into a central pooled fund and retain £6,000 each for local allocation. Members also agreed that a maximum level of revenue funding of £3,000 would be considered for each project but that projects over £3,000 may be considered for capital funding.

Members' Allocation Criteria for 2006/07

4. Members' Allocations can only be used for purposes that fall under Surrey County Council's legal powers. In summary, this means that funds must be used either for a Surrey County Council service, or under the power to promote the social, economic or environmental well-being of the area contained in the Local Government Act 2000.

5. Criteria to be considered should include whether projects:

- a. support the priorities of Making Surrey a Better Place:
 - to learn and develop
 - to live and do business
 - to travel
 - where vulnerable people are more independent
 - where people feel safe
 - where everybody matters
- b. support the priorities of the Community Strategy for Surrey Heath:
 - Health
 - Housing and Employment
 - Transport
 - Safety
 - Community Support
 - Education
 - Environment
- c. Meet demonstrable local needs
- d. Be possible to implement within the time and budget, offer value for money, have a clear audit trail and demonstrate its impact within 12 months of receiving funding.
- e. The funding needed is "one-off". Any organisation that uses funding from this source will have to make arrangements for securing any future ongoing funding necessary for their project.
- f. The project will give long-term benefit and be preventative in purpose.
- g. The project targets more disadvantaged areas or communities.
- h. Local Committee funding will unlock more funding from other sources.
- i. There is no other probable alternative source of funding

The funding should not:

- be used to fund schools for the direct delivery of the National Curriculum as this is already resourced on a formula basis by the County Council
- be used as a "grant" to an individual
- sponsor a political party, including contributing to the expenses of any conference, meeting or other event organised by or on behalf of the party.

Capital Funding

6. The £35,000 capital is primarily allocated for support to the voluntary sector, however this funding may be used for other functions.

Members' Allocation Procedure for 2006/07

- 7. To be considered projects need to be sponsored by their local County Councillor in the first instance.
- 8. If the local County Councillor feels that a project meets the criteria and wishes to sponsor the project and put it forward to the Local Committee for approval, then a bid form needs to be completed by the group applying for funding and returned to the Local Partnerships Team. The Local Partnerships Team will confirm eligibility and, if appropriate, will ensure the project is included in the next Members Allocations Local Committee report for Local Committee approval.
- If the Local Committee approves the funding then the Local Partnership Team will forward a Service Level Agreement to the group for completion and on receipt of a fully completed Service Level Agreement form will ensure payment is made.

PROPOSALS FROM POOLED BUDGET

10. Voluntary Services Surrey Heath

Contribution towards a feasibility study to look at the need for a furniture store in Surrey Heath and produce a business plan to support project planning. A furniture store would reduce the volume of waste by collecting and recycling household goods and distributing them to those in need. This is a partnership project being managed by VSSH and includes Surrey County Council, Surrey Heath Borough Council, Accent-Peerless and others.

Project cost £10,000

Amount requested £4,000 (40%)

This level of funding is above the agreed threshold of £3,000 for bids. However, this project could have significant benefits for local families in need and will support waste reduction and recycling.

11. Voluntary Services Surrey Heath

Funding for a one year pilot of the Grant Finder database. This database will allow local groups to access up to date information on grants available to them for specific projects. This project will support local groups in gaining funding and will seek to increase the amount of funding brought into Surrey Heath.

Amount requested £2,056.25 (100%)

12. Surrey County Council's Local Transportation Service

Funding to convert 6 speed check VMS signs from battery power to solar power. This will mean that signs will run from renewable energy which will result in longer operation times and reduced manpower required to support them as batteries will not need changing and recharging.

Project cost £3,400

Amount requested £3,400 (100%)

This level of funding is above the agreed threshold of £3,000 for bids. However, this project will greatly increase the effectiveness of the VMS signs and their impact on road safety in Surrey Heath. It will also save future costs

by using renewable energy and reducing the amount of staff hours needed to support the signs.

13. Camberley Town Youth Football Club

Funding for a secure area to house a storage container for training kit and aids for the whole club (ages 7 - 18). This will be put in at Kings International College who are supporting this project. This security will mean that kit can be kept on site and will not need off site storage areas and transport to and from training.

Amount requested £1,730 (100%)

14. Heatherside Community Celebration Day

Contribution towards a family community celebration to commemorate 30 years of the local Church in the community. This event seeks to foster a village community feel and encourage community cohesion.

Amount requested £2,000 (44%)

15. Surrey Heath Infant Children's' Music festival

Contribution towards to enable 25 children from each of the 15 schools across Surrey Heath come together to perform songs and experiment with music in a supported environment.

Amount requested £1,000 (66%)

16. Camberley Fire Station Youth Liaison Project

Funding for equipment to be used in Surrey Heath to support youth intervention projects including "Fire fighter for a day" and junior citizens projects. These will result in a reduction of unnecessary fires and associated injuries to young people.

Project cost £3,000

Amount requested £3,000 (100%)

17. Basingstoke Canal Canoe Club

Contribution towards new canoes and safety equipment to allow courses and playschemes for young people in Surrey Heath to continue. The existing canoes are old and in need of replacement to ensure that young people can continue to learn canoeing safely.

Project cost £3,500

Amount requested £2,000 (57%)

18. Watchetts Junior School

Contribution towards refurbishment of pond to attract wildlife, provision of shaded area for children to sit and a raised vegetable growing area. This will add to the children's learning experience and give them additional resources during break times.

Project cost £2,880

Amount requested £1,500 (52% plus £500 from Fred Chipperfield's allocation to bring a total percentage of 70%)

19. Surrey County Council - Local Transportation Service

Funding for a Speed Data Recorder to allow speed assessments to be carried out on local roads. The data will be used to assess concerns and target speed control measures to where they are most needed. The recorder will also be used to assess the impact of road safety campaigns.

Amount requested £1,116.68 (44% however an additional contribution of £1,441.57 is proposed from the capital fund which will raise this percentage to 100%)

20. St Michael's Community Project

The St Michael's Community Project has been running since 2000 and focuses on a specific area of St Michael's. The project has worked with the Youth Development Service to run a Duke of Edinburgh awards course with local young people. Additional funding will allow new community projects to take place. The group is a partnership between Surrey County Council, Surrey Heath Borough Council, Peerless Housing Association and Surrey Police. This allocation supports local self reliance work.

PROPOSALS FROM CAPITAL BUDGET

21. Royal British Legion

Contribution towards essential repairs to the flat roof at the club at Victoria Avenue, Camberley. The roof leaks which causes damage to the building and property within which has resulted in the club being closed during heavy rain in recent months. Work will start in early March 07 and should take 7 days to complete.

Amount requested £3,000 (33%)

22. Cordwalles Junior School

Contribution towards a new minibus and garage that will be used by the school to take children to join with other school in events including sporting activities. It will also be used to take children on trips into the local community to enrich their learning experience.

Project cost £31,000

Amount requested £3,000 (10%)

23. Chobham Rugby Football Club

Contribution to an extension of the car park to alleviate parking issues. Additional off street parking will keep surrounding areas clear and reduce the numbers of children needing to cross Windsor Road to access the ground.

Project cost £11,200

Amount requested £3,000 (26%, however an additional contribution of £2,000 is proposed from Lavinia Sealy's allocation which will raise this percentage to 45%. This will also raise the total allocation to above the agreed limit of £3,000 for revenue funding. However, this £3,000 is from capital funds and Members have agreed that projects over £3,000 may be considered from capital funds)

24. St John's Ambulance.

Funding of a new full-sized skeleton to support training in first aid and physiology.

Project cost £196.99

Amount requested £196.99 (100%)

25. St Paul's Church

Contribution to a cycle shelter at St Paul's Church, Camberley. This will enable people to store their bicycles safely at the church and keep them dry during inclement weather. This will encourage the congregation to cycle where possible.

Project cost £2,044.50

Amount requested £1,000 (49% however an additional contribution of £785 is proposed from Maurice Neighbour's allocation which will raise this percentage to 87%)

26. Surrey County Council - Local Transportation Service

Funding for a Speed Data Recorder to allow speed assessments to be carried out on local roads. The data will be used to assess concerns and target speed control measures to where they are most needed. The recorder will also be used to assess the impact of road safety campaigns.

PROPOSALS FROM INDIVIDUAL REVENUE ALLOCATIONS

27. Pine Ridge School

Funding for a garden shed and plant house. This will allow safe storage of tools and equipment and allow early planting of seedlings. Many families who attend the school live in homes without a garden, this project will allow them to experience new activities and broaden their skills.

28. St Paul's Church

Contribution to a cycle shelter at St Paul's Church, Camberley. This will enable people to store their bicycles safely at the church and keep them dry during inclement weather. This will encourage the congregation to cycle where possible.

Amount requested £785 (38% however an additional contribution of £1,000 is proposed from Maurice Neighbour's allocation which will raise this percentage to 87%)

Amount requested £3,000 (50%, however an additional contribution of £3,000 is proposed from Fred Chipperfield's fund which will raise this percentage to 100%)

Contribution to an extension of the car park to alleviate parking issues. Additional off street parking will keep surrounding areas clear and reduce the numbers of children needing to cross Windsor Road to access the ground.

Funding for a set of vandal proof shutters for the clubhouse, this will reduce vandalism and protect equipment.

Funding for picnic tables and benches so children have somewhere to sit.

40. 4th Frimley Scouts

Funding for repairs and redecoration of toilet facilities and emergency signs and lighting at the scout hall on Heatherside. The hall is used by the Beavers, Cub Scouts and Scouts. Children attend from across Heatherside and Deepcut.

Amount requested £2,000 (100%)

41. Surrey County Council - Local Transportation Service

Funding for speed safety measures to include vehicle activated signs for use in Surrey Heath to support driver education and speed restriction enforcement programmes.

Amount requested £1,000

42. Frimley Community Centre

Contribution towards paving and drainage improvements. Modifications are needed at the entrance to the centre to reduce the risk of flooding during heavy rainfall. This makes is difficult for people to access and exit the centre safely.

43. Frimley and Camberley Age Concern.

Funding for a carers respite sitting service. Carers will be given a short break to allow some personal time by the provision of trained sitters to offer short term care.

Funding of new flooring in the toilet area to improve the facilities for the users and visitors.
