There have been no incidents of flooding since the last meeting. The Flooding Task Group continues to meet and will be reporting to Surrey County Council's Environment and Select Committee in January 2008. The Borough Council's Land Drainage engineer continues to work closely with land-owners and local organizations to resolve issues. A multi-agency meeting is due to be held on 1<sup>st</sup> November to look at remedial work undertaken and review the Borough Council's emergency plan procedures for flood events in combination with those of other organizations.
