

OFFICER REPORT TO LOCAL COMMITTEE (Surrey Heath)

COMMUNITY SAFETY

9 July 2009

KEY ISSUE

The report provides an update on the work of the Safer Surrey Heath Partnership and plans for the coming year. Borough and police partners have also contributed to this report and will attend the Local Committee.

SUMMARY

The county of Surrey is one of the safest counties in England, and Surrey Heath has a low incidence of crime with a fall of 6% in reported crimes over the last year.

The Safer Surrey Heath Partnership has achieved many of its objectives in 2008-9 and agreed a range of actions to deliver the objectives in its 2009-10 Partnership Plan.

OFFICER RECOMMENDATIONS

The Local Committee (Surrey Heath) is asked to agree to:

- (i) delegate responsibility for expenditure of the County Council's local crime & disorder funding (£14,500) in Surrey Heath to the Area Director;
- (ii) endorse the importance of the contribution of all services towards community safety and progress made;
- (iii) that a county councillor be nominated to attend the Surrey Heath Partnership (including the CDRP).

INTRODUCTION AND BACKGROUND

1. The Safer Surrey Heath partnership comprises statutory representatives from six agencies: Surrey Police, Surrey County Council, Surrey Heath Borough Council, the Primary Care Trust, Surrey Fire & Rescue Service and the Police Authority. In the Crime & Disorder Act 1998 (amended 2006), a local crime and disorder reduction partnership (CDRP) is a statutory requirement with the function of auditing and monitoring local incidences of crime, and working together to devise and deliver an effective strategy to address it.

2. Section 17 of the 1998 Crime and Disorder Act requires local authorities to consider the crime and disorder implications of all their activities and functions, and do all that they reasonably can to reduce these problems. Surrey County Council services make an active contribution to crime prevention locally, through work with children and young people, Trading Standards, highways, countryside rights of way, and other key services. Public services are expected to have regard to S.17, and to design out crime as far as possible especially when developing new amenities.

- 3. The working group of officers for the CDRP undertook the annual strategic assessment of crime, disorder and anti-social behaviour in the borough in the latter part of 2008, in preparation for updating and refreshing the Partnership Plan 2009-10 with current objectives and activities, which is attached at **Annex 4** (and may be downloaded from a partnership website www.safersurreyheath.org.uk).
- 4. The CDRP is assisted in delivering its targets by systematic work undertaken through two important multi-agency meetings:
 - the Joint Action Group (JAG), which meets monthly to review local hotspots for anti-social behaviour and to agree actions to tackle the behaviour;
 - the Community Incidents Action Group (CIAG) which meets monthly to monitor individuals having an impact on the community through their behaviour, and to agree and implement interventions to address this behaviour.
- 5. A number of other multi-agency meetings manage other aspects of crime in the division, including one set up to monitor "prolific and persistent offenders" (PPOs), the Multi-Agency Risk Assessment Conference (MARAC) to address high risk cases of domestic abuse, and the Multi Agency Protection Panel (MAPPA) which assesses individuals who may pose a risk to the public.

ANALYSIS

- Surrey remains one of the safest counties in England according to Home Office recorded crime data 2008-9, and Surrey Heath's crime rate has decreased by 6% in the last year and was within the lowest quintile for England in 2008. (see Annex 1 latest recorded crimes - Surrey).
- 7. Serious violence against the person has fallen by just over 55%. Vehicle interference and tampering has fallen by 43% with other vehicle crime falling by 26%. There have been increases in domestic burglary (20%), theft and handling stolen goods (15%) and fraud & forgery (38.5%) These are most probably linked to the credit crunch.
- 8. Surrey Police have targeted serious violence against the person and this crime remains at very low levels in the borough only 1 crime was classified as such last year and there has been no increase in the current year. However, there has been a small increase in other violent crimes including woundings, and incidents of domestic abuse reported to the police that have been attributed in part to the drive to increase the number of victims seeking help and the economic downturn.
- 9. The Surrey Police website, www.surrey.police.uk, provides comprehensive data at borough and ward level on the latest crime figures and this data is refreshed every month (select Crime maps and statistics on the homepage). The Surrey Heath neighbourhood pages include details of the local policing team and how to

- contact them, together with information about current priorities and concerns. Details of neighbourhood panel meetings are included in **Annex 2** and a map of the Surrey Heath neighbourhoods is at **Annex 3**.
- 10. Residents can report crime by calling 999 (if the matter is serious and urgent), or by calling Surrey Police on 0845 125 222 for non-emergency reports. If they wish to report anti-social behaviour, residents can call their neighbourhood police officer to describe the problem, or use on-line anti-social behaviour reporting forms which may be downloaded from: www.safersurreyheath.co.uk. This information is then sent direct to the responsible officer to address.

Strategic assessment of needs and concerns

11. Following the 2006 review of the 1998 Crime and Disorder Act, the government issued guidance in 2007 requiring authorities to undertake annual strategic assessments to provide partnerships with recent intelligence and evidence to help them prioritise their work. This annual assessment is used to produce a Partnership Plan specifying objectives and actions (see Annex 4). The assessment draws on local evidence, ranging from crime data to traffic accident analysis from Surrey highways and records from the borough of damage and graffiti. Public survey data is also taken into account.

Partnership successes in 2008/9

- 12. The Partnership has continued to monitor incidents affecting the community across the borough and has tackled hotspots where there was evidence of a cluster of reports. A number of individuals were supported by partners through the CIAG group and subsequently removed from the agenda because of an improvement in their behaviour. At May 2009, only two Anti-Social Behaviour Orders were in place against Surrey Heath residents, reflecting the preventative work undertaken with individuals to reduce their anti-social impact on the community.
- 13. The Partnership gave financial support to several projects in 2008/9:
- Surrey Women's Aid outreach service to people experiencing domestic abuse (with Surrey Heath and Woking boroughs), the partnership also supported local events to mark Domestic Abuse Awareness Week in November 08.
- the Surrey Fire & Rescue Service Youth Engagement Scheme, which trains "at risk" young people to help them become responsible citizens.
- Funding to support the work of Youth Cafes in Surrey Heath including offering guidance and advice to new cafes.
- Supporting young people to find more beneficial ways to spend their free time e.g. cadet fees and army outreach courses.
- Funded a Taxi Marshall scheme in the town centre that assisted in reducing incidents at taxi ranks which tend to be flash point when licensed premises close.
- Supported community events e.g. the Heatherside Halloween Event.
- Financed additional connection point for mobile CCTV cameras to allow more areas to be covered.
- Produced anti-vandalism leaflets to be used around the borough's parks and open spaces.
- Purchased a new partnership van to support partnership activities including education and enforcement events.
- Gave start up funding to the Street Angels schemes which is due to start later in the year.
- Contributed funding to Neighbourhood Watch to produce their newsletter.
- Provided marketing support for the SNAP discos held at Camberley theatre.

- 15. The main project being driven forward by the partnership is the Heatherside recreation project. Following agreement from the Safer Surrey Heath Partnership a task group has worked to address the view points from stakeholders and the community. Agreement was reached earlier this year that 4 options were to be presented for consideration by the community as part of an extensive community consultation exercise. Three of the options are around new community recreation facilities and the fourth option is to do nothing.
- 16. The consultation is due to commence with a launch at Heather Ridge School on Monday 13 July from 6pm until 8pm. Invitations will be sent out to all residents in the Heatherside ward this week. The presentation will be available to view from 14 31 July in the foyer of the community centre. Officers will be present on Sat 18 July 10am-12pm, Mon 20 July 4pm 8pm, Sat 25 July 10am-12pm and Mon 27 July 4pm-8pm.
- 17. A second letter will send out on the 27 July, which will contain a survey that will enable up to 5 people per household to participate within the consultation, together with a pre-paid envelope for the returns. The aim is to provide an opportunity for all family members who reside within the Heatherside ward a chance to take part. The information will then be collated and a further public meeting is scheduled to take place at Heather Ridge School on Wednesday 21st October 2009 at 6.30pm to feedback the outcome, due to the previous sensitivities, the preferred option will be subject to planning consent.
- 18. Community days have been held in the past year at Old Dean, Bagshot, St Michael's and Frimley. These co-ordinated partnership efforts show residents that statutory and voluntary agencies were working together to tackle crime. Forthcoming Community Days in Old Dean, St Michael's and other locations, show the public that services such as trading standards, youth services, street cleansing and leisure & recreation are working alongside neighbourhood police to make their streets and parks safer and more pleasant places.
- 19. Surrey PCT organised the Big Drink Debate in 2008 and received 208 responses from Surrey Heath residents (5% of total responses). The PCT has launched an alcohol strategy for Surrey which will target hazardous drinkers, and young people aged under 24, as well as ensuring effective law enforcement on alcohol. The Partnership contributed to the survey but promoting the questionnaire and having a stall in the town centre to raise awareness of the issue.

Partnership Plan 2009-10

- 20. The CDRP strategy group used the results of the strategic assessment to draft a list of priorities for action in the coming year. The Partnership has agreed to target the following themes:
 - To reduce fear of crime
 - To reduce public place disorder, e.g. secondary fires, alcohol-related disorder and criminal damage
 - To reduce priority crimes, e.g. domestic abuse, household burglaries and theft of vehicles
 - To reduce substance misuse

- 21. The total budget allocated to the CDRP in 2008-9 was as follows:
- Basic Command Unit Fund (revenue) £30,063
- SSC Fund (capital) £74,918
- Partnership fund (revenue) £62,000

Other partnership developments

22. It is expected that, in the course of 2009, the Government Connect initiative will be implemented. This will enable partners from various statutory agencies to exchange personal and confidential information electronically using a secure network, which will increase ease of communication in relation to the groups such as CIAG.

Safer and Stronger Communities Partnership Board

23. Community safety forms part of the "safer and stronger" strand of Surrey's Local Area Agreement (LAA) with government. The Safer and Stronger Communities Partnership Board was established in 2005-6 – chaired by the Chief Constable it includes senior representatives from Probation, Surrey Police Authority, Surrey PCT's Public Health, Surrey Community Action, Surrey Community Safety Unit, borough chief executives, youth justice service, Government Office for South-East and CDRP chairmen. It allocates funding from the Area Based Grant (a non ring-fenced general grant from Government) to individual CDRPs, and will agree over summer/autumn 2009 its future strategy for funding crime and disorder work.

OPTIONS

24. The Committee has two options: to delegate representation including finance decisions to the Area Director who attends meetings of the Crime and Disorder Reduction Partnership, or to require that all proposals for CDRP expenditure are brought before the Local Committee. The latter option would be impractical, given the timescales for such decisions and the relatively modest sums of expenditure involved.

CONSULTATIONS

25. Surrey Police conduct regular neighbourhood panel meetings at local level with members of the public, as part of the neighbourhoods agenda, together with a quarterly Policing Forum. Details of forthcoming Panel meetings and neighbourhood officers are laid out in **Annex 2**.

FINANCIAL AND VALUE FOR MONEY IMPLICATIONS

26. None.

EQUALITIES AND DIVERSITY IMPLICATIONS

27. The CDRP funding contributes to a domestic abuse outreach service provided under contract by Surrey Women's Aid. Support is provided to people, referred by the police and other local agencies, who have experienced various types of domestic abuse. Service data is attached in **Annex 5.**

CRIME AND DISORDER IMPLICATIONS

28. The Crime and Disorder implications are implicit in the report.

CONCLUSION AND RECOMMENDATIONS

29. Members are asked to agree to delegate responsibility for expenditure of the County Council's local crime and disorder funding in Surrey Heath to the Area Director.

REASONS FOR RECOMMENDATIONS

30. The delegation is recommended to facilitate timely decision making in response to fast moving trends in patterns of crime and disorder locally.
