

# OFFICER REPORT TO LOCAL COMMITTEE (SURREY HEATH)

## ANNUAL REVIEW OF ON-STREET PARKING IN SURREY HEATH

## **14 OCTOBER 2010**

## **KEY ISSUE**

To approve arrangements for progressing Traffic Regulation Orders for proposed amendments to on-street parking restrictions in the Surrey Heath borough.

#### SUMMARY

Officers have completed a review of on-street parking in Surrey Heath, and identified changes in restrictions which would benefit road safety and reduce instances of obstructions and localised congestion.

## OFFICER RECOMMENDATIONS

## The Local Committee (Surrey Heath) is asked to agree:

- (i) That the proposed amendments to on-street parking restrictions in Surrey Heath as described in this report and shown in detail on drawings presented at this committee meeting as annex A (Drawings 1, 3-16, and 19-20) are agreed.
- (ii) The Local Committee allocates funding as detailed in paragraph 7 of this report to proceed with the introduction of the parking amendments.
- (iii) That the intention of the County Council to make an Order under the relevant parts of the Road Traffic Regulation Act 1984 to impose the waiting and on street parking restrictions in Surrey

Heath as shown on the drawings in annex A (Drawings 1, 3-16, and 19-20) be advertised and that if no objections be maintained, the Orders be made.

#### 1 INTRODUCTION AND BACKGROUND

- 1.1 At local committee on 15 July 2010, a decision on the Surrey Heath Parking Review was deferred until this October meeting, when members would have a better understanding of the funding situation. Since this meeting, 3 proposals (2 located in Bisley, and 1 located in Camberley) have been rescinded for reasons given in paragraph 3 of this report.
- 1.2 Surrey County Council's Parking Strategy and Implementation Team (Parking Team) carry out reviews of on-street parking restrictions across Surrey.
- 1.3 An assessment list comprising over 130 requests for parking restrictions from residents, councillors and SCC engineers over the last year were collated and used as the basis for the Surrey Heath parking review.
- 1.4 Each feasible request was assessed based on several factors including road safety, localised congestion, effect on emergency services and bus operators and levels of support e.g. supported by county member, local borough/district council, high resident demand etc.
- 1.5 A review of the Camberley Controlled Parking Zone was carried out separately to this review, by a consultant working on behalf of Surrey County Council. All proposals within this CPZ were included in the 'Camberley Controlled Parking Zone Review' committee report, presented to this committee on 15 July 2010.

#### 2 REVIEW OF RESTRICTIONS

2.1 The review was carried out in two stages: -

Stage one being an initial "desktop" exercise, which involved eradicating requests for refreshment of existing restrictions only and requests for restrictions which were either clearly not practical or feasible.

- Stage two involved site visits to all remaining locations, which were assessed using the criteria explained above.
- 2.2 Following stage two of the review, some suggestions and requests were not progressed due to there being insufficient evidence to suggest there was a parking problem which warranted restrictions, or where no feasible or practical solution was found.
- 2.3 The locations where officers consider new or amended restrictions may be of benefit are listed below. These were discussed with the Surrey Heath Parking Task Group on 28 June 2010.

#### 3 PROPOSED AMENDMENTS

#### **CAMBERLEY**

## Drawing No. SH0710-01 King's Ride

Introduce double yellow lines to maintain sight lines and road safety. A dip in the road makes parking here particularly hazardous for those exiting Old Green Lane, who are unable to see approaching vehicles.

#### **BAGSHOT**

## Drawing No. SH0710-03 High Street

Increase the parking time allowed on the parking bay outside numbers 51-61 to 2 hours. This will allow visitors and shoppers to park on the High Street for longer than the current 30 minute limit.

**Note:** This is not likely to affect revenue for the nearby Bagshot Car Park as it currently allows 2 hours free parking.

## Drawing No. SH0710-04 Church Road

Upgrade existing single yellow line restriction to double yellow lines with a partial reduction outside properties 50 and 52, to maintain traffic flow and road safety along Church Road at all times.

#### **FRIMLEY**

## Drawing No. SH0710-05 Partridge Close

At the request of residents via a petition, introduce a residents parking scheme to prevent parking in the close by non residents, except those using the proposed 2 hour parking bays provided to allow for short term visits.

In accordance with the forthcoming countywide standard, the permit provision criteria and associated costs are to be as follows: -

- If the householder has no off-street parking they are entitled to up to two residents permits.
- If the householder has one off-street parking place they are entitled to a maximum of one resident permit.
- If the householder has off-street parking for two or more vehicles they are not entitled to any residents permits.
- Every household is entitled to apply for up to 30 daily visitor permits per year, regardless of whether they have off-street parking or not.
- Cost or first resident permit: £50 per annum.
- Cost of second resident permit: £75 per annum.
- Cost of each daily visitor permit: £2

The permit allocation limit is currently under review as part of the consultation on the new parking strategy, and may therefore be subject to change in the future.

## Drawing No. SH0710-06 Sheridan Road j/w Leonard Close

Introduce double yellow line on one part of the junction to maintain sight lines and road safety.

## Drawing No. SH0710-07 Oakway Drive

Revoke existing single yellow line restriction outside properties 9,11 and 13 at the request of these residents.

## Drawing No. SH0710-08 Bicknell Road

Introduce double yellow lines outside properties 1a to 1d to maintain sight lines and road safety for nearby junctions.

## Drawing No. SH0710-09 Grove Cross Road

Make current 1 hour parking bay unrestricted to increase the use of this bay and to ease the pressure on surrounding residential streets. For example the residents of Stream Cottages currently have to compete with non residents for the limited on street parking in Grove Cross Road.

#### FRIMLEY GREEN

#### Drawing No. SH0710-10 Bowling Green Court

Introduce a single yellow line restriction in the currently unrestricted section of Bowling Green Court. This will prevent large goods vehicles from having to pass parked cars by driving up onto the verge on the opposite side, causing damage to the verge and kerbing. Limited restrictions only are required as difficulties only occur during the daytime.

#### Drawing No. SH0710-11 Buckhurst Road

Introduce double yellow lines on the junctions and bends to maintain sight lines and road safety.

## Drawing No. SH0710-12 Gresham Way

Introduce double yellow lines opposite the Cross Farm Infant School to prevent parking opposite the school entrances and on the bend.

#### WINDLESHAM

Drawing No. SH0710-13 Church Road

At the request of Surrey Police, introduce double yellow lines to prevent parking on the bend.

Drawing No. SH0710-14 Chertsey Road

Extend existing double yellow lines by School Lane (private) to maintain sight lines for vehicles exiting onto Chertsey Road.

### **LIGHTWATER**

Drawing No. SH0710-15 Guildford Road (Service Road)

Introduce double yellow lines around the turning head opposite numbers 140 and 140a, to prevent parking and allow vehicles to turn without being forced to use the private driveway of number 140a.

Drawing No. SH0710-16 Guildford Road (near Post Office)

Extend existing limited waiting parking bay towards number 84 to allow for increased parking demand.

#### **WEST END**

Drawing No. SH0710-19 Benner Lane

Revoke existing school keep clear outside the Holy Trinity School and introduce a single yellow line restriction across the two lay-by parking areas (separated by a kerb build out), including the kerb build out itself. This will prevent parking in the lay-bys but allow for the areas to be used for pick ups and drop offs by parents and carers.

Drawing No. SH0710-20 Gosden Road

Introduce double yellow lines on parts of the road considered to be unsafe or obstructive to through traffic and private accesses. Additionally to prevent parking on and damaging grass verges.

## **RESCINDED PROPOSALS SINCE 15 JULY 2010 COMMITTEE**

#### **CAMBERLEY**

Drawing No. SH0710-02 A30 London Road (Service Road by no.593)

Revoke existing double yellow lines due to a planned reconstruction of this area to a shared surface.

**Reason for not proceeding:** This proposal was a result of a redevelopment, which is due to take place on this part of the A30 London Road. It has now been decided that the legal advertisement required to revoke these existing waiting restrictions will be funded for and progressed as part of this redevelopment scheme.

#### **BISLEY**

## Drawing No. SH0710-17 Clews Lane

Introduce double yellow lines on the north side of the road between Donnafields (private) and Pilgrims Way, to prevent parking which reduces the road to single file traffic between the main road and bend.

## Drawing No. SH0710-18 Mainstone Road

Introduce double yellow lines on the bend to maintain access for large goods and refuse vehicles, which are currently being forced to drive onto the adjacent verge in order to pass parked vehicles.

Reason for not proceeding: Since July committee, the Parking Team has discussed these proposals with Bisley Parish Council, who were not in favour of the restrictions due to concerns over the displacement of vehicles to other parts of the road and nearby areas, and the prevention of residents from parking outside or near to their homes. The Parking Team will therefore monitor the situation, and reassess these locations as part of the next parking review.

## **Other Locations Assessed**

The following list provides the locations that were assessed and considered not appropriate to introduce permanent parking controls at this time. This is because of various reasons, and there are a number of locations on this list that will be re-visited as part of the next review. While every effort has been made to ensure this list is as accurate as possible, there may have been requests that do not appear in this list due to the fact the request was considered along with a nearby road during the assessment. If further clarification is sought please contact Surrey County Council's Parking Team.

## 4 CONTROLLED PARKING ZONE CONSULTATIONS

- 4.1 In preparation for this parking review, letter drops were carried out to each household located in roads where we had received requests for Controlled Parking Zones (CPZs). These roads were Station Road (Incl. The Close), Frimley; Gilbert Road, Frimley and Partridge Close, Frimley.
- 4.2 The letters explained a CPZ in detail, including the permit allocation criteria for both residents and visitors, and the likely costs of the permit. Residents were given 3 weeks to respond with their preferred option of: 'Controlled Parking Zone', 'Curfew Parking' (a short time period restriction to prevent all day parking), or 'do nothing'.
- 4.3 **Station Road (Incl. The Close), Frimley**: 69 letters were delivered with 23 responses. Of these responses, 43% were in favour of a CPZ, 17% Curfew Parking and 40% in favour of doing nothing. It has been concluded that this is not conclusive enough evidence to proceed with any proposal, and it is thought that if a CPZ proposal were to be formally advertised, the majority of residents would be against the proposal. It is therefore recommended that no further action be taken under this review.

- 4.4 Gilbert Road (Incl. Greenbanks Way), Frimley: There was a very low response rate for this area. 210 letters were delivers with only 19 responses. Of the few that responded, 47% were in favour of a Controlled Parking Zone, 37% Curfew Parking, and 16% in favour of doing nothing. Due to this disappointing level of feedback, there is not enough information for us to make any definitive conclusion about what residents would like for the road. It is therefore recommended that no further action be taken under this review.
- 4.5 **Partridge Close, Frimley:** The County Council received a petition from the residents of Partridge Close, requesting that consideration be given to providing residents parking. As a result of this, consultation letters were sent out, and of the 62% of those properties that replied, all were in favour of a Controlled Parking Zone. A proposal for residents parking is therefore presented at this committee, outlined in drawing number SH0710/05. A copy of this proposed restriction layout was sent to each resident, and all the feedback has been positive.

#### 5 STEPS TOWARDS IMPLEMENTATION

- 5.1 Subject to approval and budget provision being made available for 2010/11, it is anticipated that the formal advertising process involving notices in local newspapers and at proposed locations, will begin in Winter 2010/11. Plans illustrating the amended restrictions will also be placed on deposit in local libraries and the Surrey Heath Borough Council offices during this time.
- 5.2 This will provide the opportunity for any interested parties to lodge objections, if they do not agree with the proposals.
- 5.3 The Chairman, Divisional Member and the Parking Strategy and Implementation Group Manager will consider and try to resolve any objections. If there are unresolved objections, they will be considered in accordance with the county council's constitution.
- 5.4 Subject to approval, notices will then appear in local newspapers confirming that the County Council has made the Traffic Regulation order.
- 5.5 Finally, the new and amended parking restrictions and associated time plates will be installed on the ground in Spring 2011.

#### 6 OBJECTIONS

- 6.1 Once the amendment order is advertised, people have 28 days to lodge views and objections.
- 6.2 Objections can relate to the introduction of a new restriction. In cases where there is a coherent argument for not introducing a proposed

- restriction, it may be omitted, and the traffic order can proceed to be made for the other restrictions without the need to re-advertise.
- 6.3 If restrictions are to be added to those initially advertised, regulations require that these new restrictions must be re-advertised afresh. For this reason no additional restrictions can be added through the objection process.

#### 7 FINANCIAL AND VALUE FOR MONEY IMPLICATIONS

7.1 A budgetary provision will need to be made available by the Local Committee for the cost of the traffic regulation order and the installation of any signs and lines. This is estimated to be approximately £20,000.

#### 8 EQUALITIES AND DIVERSITY IMPLICATIONS

8.1 There are no specific equalities and diversity implications for this report.

## 9 CRIME AND DISORDER IMPLICATIONS

9.1 There should be fewer instances of obstructive parking as a consequence of the restrictions.

#### 10 CONCLUSION AND REASONS FOR RECOMMENDATIONS

- 10.1 It is recommended that the waiting restrictions are implemented as detailed in Annex A. They will make a positive impact towards:-
  - Road safety
  - Access for emergency vehicles
  - Access for refuse vehicles
  - Ease traffic congestion
  - Better regulate parking

## 11 WHAT HAPPENS NEXT

11.1 Subject to approval of the committee and budgetary provision being made available, the Traffic Regulation Order will be advertised and the restrictions implemented.
