Chobham Community Resilience Action Group

The Chobham Community Resilience Action Group (CCRAG) has over the last 6 months completed and tested its emergency plan at Exercise Watermark. The emergency team is in place but – due to an unavoidable changeover in personnel – has some people in place in a temporary capacity and is seeking active members of the Chobham community (perhaps those that are not directly affected by flooding) to come forwards and assist the community as a whole.

The group has also reinstated the flood wardens scheme and amongst other prevention measures is purchasing flood warning signs that will help alleviate secondary flooding caused by the wash from cars. The groups activities are now moving on to look at minor prevention schemes within the village and it is also looking at the possibility of fund raising to enable the major works detailed in the flood relief study to get underway.

CCRAG is always looking to add to its membership – this group is for the benefit of all those that live in the village whether directly affected by flooding or not – and it welcomes any support from the members of Surrey Heath.
