#### **KEY ISSUE**

To appoint County Council Members to represent the Local Committee on the Tandridge Community Safety Partnership for 2012/13:

To approve the terms of reference and appoint Members to the Tandridge Youth Task Group

#### **SUMMARY**

This report seeks approval for the terms of reference for the Youth Task Group and appointment of membership for the task group and the Community Safety Partnership for 2012/13.

#### OFFICER RECOMMENDATIONS

#### The Local Committee (Tandridge) is asked to:

- Agree the terms of reference for the Youth Task Groups as set in Annex A
- (ii) Confirm the membership for the Youth Task Groups as set out in paragraph 2 of Annex A
- (iii) Appoint a member of the Local Committee to the Community Safety Partnership.

#### 1. INTRODUCTION AND BACKGROUND

#### Task Groups

- 1.1 Youth Task Groups were set up in 2011 to involve Members and young people in the commissioning of Local Prevention contracts through a pre-approved provider framework. These contracts went live in April 2012. Going forwards the role of Task Groups will be to monitor and report on the progress of the Local Prevention commission, including:
  - To review the local needs of young people
  - To monitor the performance of Local Prevention contracts
  - To make commissioning recommendations to the Local Committee

Please note that the task group of the Local Committee have no formal decision-making powers and will instead make recommendations to the Local Committee.

#### Community Safety Partnership

1.2 County Member representation on the Community Safety Partnership generally falls to the chairman of the local committee. However, this must be determined in public and the nomination officially recorded.

#### 2 OPTIONS

- 2.1 The Committee can confirm the task groups (and corresponding terms of reference) set out within the report, consider new task groups, or not have any task groups. If a task group is established a provisional terms of reference should be agreed.
- 2.2 The Committee can appoint the chairman of the Local Committee or nominate another member to be a representative on the CSP.
