LOCAL COMMITTEE BUDGETS 2010-2011

17 DECEMBER 2010

KEY ISSUE AND SUMMARY

To approve applications for funding from the Local Committee's budgets and note actions carried out under delegated authority.

OFFICER RECOMMENDATIONS

The Local Committee (Waverley) is asked to:

- (i) Approve the applications for expenditure annexed to the report and the return of a grant reported at 1.2.
- (ii) Note the actions carried out under delegated authority since the last meeting.

1 INTRODUCTION AND BACKGROUND

- 1.1 At its meeting on 18 June 2010 the Committee agreed to divide its revenue and capital ("voluntary organisations") budgets equally amongst the members of the Committee and to delegate to the Area Director (Guildford and Waverley) the authority to approve budget applications (and refunds) of up to and including £1000, subject to these being reported to the Committee at the following meeting.
- 1.2 The Committee is asked to approve the return of £2500 allocated from Mrs P Frost's budget to purchase a salt/grit bin at Forge Close, Farnham. The site will receive a replacement bin funded from the Highways budget, as it was previously removed.

2 ANALYSIS

2.1 The following applications for expenditure have been approved by the Area Director since the last meeting of the Committee under his delegated authority.

2.2 One location of a salt/grit bin, purchased by Mr David Munro, has changed from Burnt Hill Road to Cobbetts Way, Farnham. The Burnt Hill Road site will receive a replacement bin funded from the Highways budget, as it was previously removed.

2.3 The sums currently remaining to be allocated in members' revenue and capital budgets are set out below. The totals take account of the applications submitted for approval at this meeting and applications which the Local Partnerships Team are aware of but have not yet been approved by the Area Director.
