#### **KEY ISSUE AND SUMMARY**

#### 1 INTRODUCTION AND BACKGROUND

1.1 At its meeting on 17 June 2011 the Committee agreed to divide its capital ("voluntary organisations") budget equally amongst the members of the Committee. It had already agreed parallel arrangements for the allocation if its revenue budget at its meeting on 18 March 2011. The Committee also resolved at its June meeting to delegate to the Community Partnership Manager and Community Partnership Team Leader (West Surrey) the authority to approve budget applications (and refunds) of up to and including £1000, subject to these being reported to the Committee at the following meeting.

The Weydon Christian Community Centre offers to facilities to a wide range of local groups and residents.

#### 7 CRIME AND DISORDER IMPLICATIONS

7.1 The Godalming District Scout Canoe Club encourages positive activities amongst young people. Traffic calming in Shamley Green and improved pedestrian crossing facilities in Haslemere would contribute to increased safety for all road-users.
