

Allocating Local Committee Funding: Members' Allocation

Local Committee for Woking 23 July 2003

KEY ISSUE:

The Local Committee has approximately £75,000 of the members' allocation budget remaining to allocate this year.

SUMMARY:

This report lists and where appropriate makes recommendations on bids received for Members' allocations which have been sponsored by at least one Member.

OFFICER RECOMMENDATIONS:

1. That Members decide whether to fund the bids for Members' allocations described in paragraph 7.

Background

- 1. The Local Committee has £107,100 Members' allocation in 2003/04, of which £32,000 has been allocated so far this year, leaving £75,000 available. Bids have been received for a maximum of £46,032.
- 2. Members are reminded that at the March meeting of the Local Committee for Woking, they expressed their intention to allocate half the budget before the summer, leaving the other half approximately \pounds 50,000 to allocate at their October meeting. If Members want to keep to this plan, they should allocate no more than \pounds 25,000 at this meeting.
- 3. The Local Director has been advised of several bids which individual Members wish to put forward in October, which could not be considered at today's meeting because they are not yet finalised. Members may therefore wish to reserve at least the \pm 50,000 they originally planned, if not more, for October decision.

Criteria

- 4. On 19 March 2003, Members set criteria to assess bids. Bids for funding from Members' Allocations are more likely to be funded if they meet the following criteria:
 - a. The funding needed is a "one-off".
 - b. The project will demonstrate its impact before the end of the financial year.
 - c. The project will give long-term benefit.
 - d. The project is preventative in purpose.
 - e. The project targets more disadvantaged areas or communities.
 - f. Surrey County Council funding will unlock much more funding from other sources.
- 5. Members decided that the Local Director would assess each suggestion to make sure that it:
 - a. supports the priorities of the Surrey Corporate Plan and Woking Community Strategy
 - b. is possible to implement within the time and budget, and offer value for money
 - c. meets criteria set by Audit (e.g. that it is legal).
- 6. Also the Local Committee decided to aim for a portfolio of schemes which overall:
 - a. include at least one comparatively large project of benefit to Woking;
 - b. benefit a variety of communities of interest (for example, young people, old people, ethnic minorities, disabled people), and different areas of Woking;

c. include a mix of large and small projects, but not a lot of very small ones;

and the Local Committee decided that a large project that benefits a lot of people will take priority over a project that benefits only a few people.

Bids received for the Members' allocation

7. The following bids for Members' Allocation have been assessed by the Local Director and meet the criteria in paragraph 5:
