

LOCAL TRANSPORTATION SERVICE CURRENT STATUS OF PROJECTS

KEY ISSUE:

To ensure Members of the Local Committee are aware of the current status of projects within the Local Transportation Service.

SUMMARY:

This report details the current status of various work programmes from enquiry to completion.

INTRODUCTION and BACKGROUND

This report is written to inform Members of the Local Committee of the current status of work programmes being undertaken by the Local Transportation Service.

- 2 The work programmes have been considered on the following basis:
 - Items not covered by Members allocation, local allocation, Local Transport Plan or revenue maintenance budget (Appendix A)
 - Local Transport Plan programme for integrated transport (Appendix B)
 - Major maintenance (Local Transport Plan funded) (Appendix C)
 - Local Capital Allocation (Appendix D)
 - Members Allocation (Appendix E)
 - Revenue funded highway maintenance (Appendix F)
- Appendix A details those work items not covered by 2003-04 budget provision through Members Allocation, Local Capital Allocation, Local Transport Plan or revenue maintenance budget. Each work item has a reference number and the current position is stated. All project proposals have been received and Members are asked to particularly review the categories "No action proposed" and "To be programmed".
 - If "No action proposed" is agreed the work item will be deleted from the list. Where "To be programmed" is used a timescale has been proposed and agreement by Members will be deemed to accept this as stated.
